**Organization of the session**

**A. Opening and duration of the session**

1. The Commission on Science and Technology for Development held its thirteenth session at the United Nations Office at Geneva from 17 to 21 May 2010. The Commission held \_\_\_\_\_ meetings (1st to \_\_\_\_\_).
2. The session was opened by the Chair, Mr. Frédéric Riehl (Switzerland), who also made a statement.
3. Also at the 1<sup>st</sup> meeting, on 17 May, the Deputy Secretary-General of the United Nations Conference on Trade and Development addressed the Commission.

4. At the same meeting, the following speakers addressed the Commission: Mr. Moritz Leuenberger, Vice-President of the Swiss Confederation and Head of the Federal Department for the Environment, Transport, Energy and Communication of Switzerland; Mr. Mohamed Naceur Ammar, Minister of Communication Technologies of Tunisia; Professor Jianxin You, Executive Deputy President of the Chinese Academy of Science and Technology Management; Mr. S. Ramadorai, Vice-Chair, Tata Consulting Services and Chair, International Chamber of Commerce BASIS Initiative; and Ms. Anriette Esterhuysen, Executive Director, Association for Progressive Communications.
5. The Commission also viewed a video message from Ms. Neelie Kroes, Vice-President of the European Commission and Commissioner for the digital Agenda.
6. At the 3rd meeting, on 18 May, the Head of the CSTD Secretariat, UNCTAD, introduced the report of the Secretary-General, contained in documents A/65/64-E/2010/12 and the Director of the Division for Public Administration and Development Management, UN/DESA, introduced the report of the Secretary-General on enhanced cooperation on public policy issues pertaining to the Internet, contained in document E/2009/92\*.

#### *Ministerial Roundtable on the follow-up to and implementation of the outcomes of the World Summit on the Information Society*

At the 2<sup>nd</sup> meeting, on 17 May, the Commission continued its ministerial roundtable and the following participants took part: Ms. Clotilde Fonseca, Minister of Science and Technology of Costa Rica; Mr. Mohamed Naceur Ammar, Minister of Communications Technologies of Tunisia; Mr. Fortunato De la Pena, Under-Secretary for Science and Technology of the Philippines; Mr. Pedro Teta, Deputy Minister of ICT of Angola; Mr. Iogenes Aybar, Vice-Minister of Science and Technology of the Dominican Republic; and Mr. Abdolmajid Riazi, Deputy Minister of ICT of the Islamic Republic of Iran.

9. At the 2<sup>nd</sup> meeting, on 17 May, the Commission held a panel discussion on the five-year overview of progress made in the implementation of the outcome of the World summit on the Information Society”.
