I am writing with regard to the latest flagrant violations of the ceasefire regime on the line of contact between the defence army of the Nagorno Karabakh Republic and the Azerbaijani armed forces.

As is evident from the information set forth in the list of ceasefire violations attached to the present letter (see annex), there is a continuous effort from the Azerbaijani side to destabilize the situation in the region. The pre-planned provocations on the line of contact this summer were examples of Azerbaijan's insistence on seeking forceful ways to deal with the Nagorno Karabakh issue.

On the night of 18-19 June 2010, a special military unit of the Azerbaijani army crossed the line of contact and penetrated into the Mardakert district of the Nagorno Karabakh Republic. This deliberate provocation by the Azeri side took place hours after the high-level trilateral meeting among the Presidents of Armenia, the Russian Federation and Azerbaijan, held on 17 June 2010 in Saint Petersburg, Russian Federation, and left four soldiers of the defence army of the Nagorno Karabakh Republic dead and four wounded.

This attack by the Azerbaijani armed forces is in complete violation of the principles and norms of international law, including the main principles of the United Nations Charter. This provocative act "can only be seen as an attempt to damage the peace process", as was noted in the 21 June statement of the Co-Chairs of the Organization for Security and Cooperation in Europe Minsk Group — France, the Russian Federation and the United States of America.



Such behaviour by Azerbaijan is a serious threat to the peace and stability in the region. It is a violation of the 1994 ceasefire agreement between Azerbaijan, Nagorno Karabakh and Armenia and is contrary to the stated commitment to refrain from the use of force or the threat of the use of force.

Armenia strongly condemns the use of force by Azerbaijan. Belligerent provocations in this fragile security environment may have unforeseen consequences, and, therefore, the international community should resolutely condemn the continued provocations and escalation of tension by Azerbaijan.

I should be grateful if you would have the present letter and its annex circulated as a document of the General Assembly, under agenda items 13, 14 and 18, and of the Security Council.
