*A panel discussion on the topic of “Coordinating efforts for achieving the health-related Millennium Development Goals” was held. It was chaired by Mr. Wetland (Norway), Vice-President of the Council, and moderated by Mr. Tore Godal, Special Adviser to the Prime Minister of Norway. The panellists were Mr. Julian Lob-Levyt, Executive Secretary, GAVI Alliance; Mr. Michel Kazatchkine, Executive Director, Global Fund to Fight AIDS, Tuberculosis and Malaria; Mr. Keith Hansen, Sector Director for Human Development in Latin America and the Caribbean, World Bank; Mr. Philippe Douste-Blazy, Special Adviser on Innovative Finance for Development; Ms. Carissa Etienne, Assistant Director-General for Health Systems and Services, World Health Organization; and Mr. Leonard J. Edwards, Personal Representative of the Prime Minister of Canada for the G-8 and G-20 Summits. Presentations were made by the panellists and a statement was made by the discussant. They then responded to comments made and questions raised by the delegations of Belgium (on behalf of the European Union), the Republic of Korea, Mongolia and Brazil. The moderator made concluding remarks and closed the panel discussion.*
