## **Expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court**

### **Report of the Secretary-General**

#### *Summary*

The present report is submitted pursuant to paragraph 10 of General Assembly resolution 64/9, in which the Assembly emphasized the need for the Secretary-General to inform the Assembly at its sixty-fifth session of the expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 August 2009 to 30 June 2010, the United Nations provided facilities and services to the International Criminal Court in the amount of \$534,913, including International Telecommunications Satellite Organization (INTELSAT) satellite communications, conference and related services, costs for staff who worked exclusively on matters pertaining to the Court, language proficiency examinations, field security and library services. In addition, during the same period, the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC) provided transportation and other services amounting to \$48,407 to the International Criminal Court.
2. Additional expenses in the amount of \$805,478 were incurred by the United Nations Office at Nairobi, the International Tribunal for the Former Yugoslavia, the International Criminal Tribunal for Rwanda, the United Nations Office at Geneva and the United Nations Logistics Base, Brindisi, Italy, for services provided for the same period.
3. The Court has regularly reimbursed the United Nations upon receipt of invoices.
4. A narrative of itemized details of facilities and services provided to the Court for the period from 1 August 2009 to 30 June 2010 by the United Nations and MONUC are contained in annexes I and II, respectively, and by the various offices away from Headquarters in annex III.
