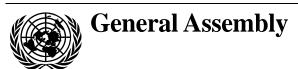

# Revitalization of the work of the General Assembly

### **Report of the Sixth Committee**

#### I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the sixty-fifth session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 17 September 2010, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work for the sixty-sixth session of the General Assembly.
- 3. The Committee considered the item at its 28th meeting, on 11 November 2010 (see A/C.6/65/SR.28).

#### II. Consideration of draft decision A/C.6/65/L.21

- 4. At the 28th meeting, the Chair introduced a draft decision containing the provisional programme of work of the Committee for the sixty-sixth session of the General Assembly, as proposed by the Bureau (A/C.6/65/L.21).
- 5. Statements were made by the representatives of Chile (on behalf of the Rio Group), Belgium (on behalf of the European Union) and Ghana (on behalf of the Group of African States).
- 6. At the same meeting, the Committee adopted draft decision A/C.6/65/L.21 (see para. 7).





## III. Recommendation of the Sixth Committee
