# Election of a member to the Permanent Forum on Indigenous Issues

#### Note by the Secretary-General

1. At its 8th plenary meeting, held on 28 April 2010, the Economic and Social Council, inter alia, elected eight members to the Permanent Forum on Indigenous Issues for a three-year term beginning on 1 January 2011 (see Council decision 2010/201 B).

2. In a letter dated 29 October 2010, the Secretariat informed Governments that one elected member of the Permanent Forum, Mirian Masaquiza (Ecuador), had resigned from her seat and requested States Members of the United Nations that are members of the Group of Latin American and Caribbean States to present their nominations to fill the seat by 25 November 2010.

3. Accordingly, the Secretariat has received nominations from the Governments of Bolivia (Plurinational State of) and Guyana. The term of office would begin on 1 January 2011 and expire on 31 December 2013.
