

Report of the Secretary-General

I. Introduction

- 1. In paragraph 14 of its resolution 64/15, the General Assembly requested the United Nations Office for Partnerships, through the Secretary-General, to submit a comprehensive report to the Assembly at its sixty-fifth session on the status of the United Nations Trust Fund for Partnerships Permanent Memorial.
- 2. The present report is submitted pursuant to that request.

II. Status of the Trust Fund

- 3. As at 30 November 2010, a total of \$801,298 had been received in contributions to the Trust Fund, comprising \$773,548 in contributions from Member States and \$27,750 in private donations. The breakdown of the contributions is provided in the annex to the present report. With respect to expenditures from the Trust Fund, it may be noted that only a small amount of approximately \$27,000 has been utilized, out of the private donations, primarily for the engagement of consultants.
- 4. The committee of interested States established to oversee the permanent memorial project (Permanent Memorial Committee) is continuing its efforts to raise additional contributions from non-Member States. The Committee is also committed to ensuring that voluntary funds received from Member States are earmarked for tangible aspects of the project, including the international design competition and the construction of the monument. The United Nations Office for Partnerships has administered the Trust Fund accordingly.
