

Credentials of representatives to the sixty-fifth session of the General Assembly

Report of the Credentials Committee

Chair: Mr. Vanu Gopala Menon (Singapore)

- 1. At its 26th plenary meeting, on 5 October 2010, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its sixty-fifth session consisting of the following Member States: Bahamas, China, Finland, Gabon, Guatemala, Kenya, Russian Federation, Singapore and United States of America.
- 2. The Credentials Committee held its meeting on 18 November 2010.
- 3. Mr. Vanu Gopala Menon, Permanent Representative of Singapore, was unanimously elected Chair.
- 4. The Committee had before it a memorandum by the Secretary-General dated 16 November 2010, concerning the credentials of representatives of Member States to the sixty-fifth regular session of the General Assembly.
- 5. As indicated in paragraph 1 of the memorandum of the Secretary-General, formal credentials in the form required by rule 27 of the rules of procedure of the General Assembly had been submitted by the following 137 Member States in respect of their representatives to the sixty-fifth session of the General Assembly: Afghanistan, Albania, Algeria, Andorra, Angola, Argentina, Armenia, Australia, Austria, Azerbaijan, Bahamas, Bahrain, Bangladesh, Barbados, Belarus, Benin, Bhutan, Bosnia and Herzegovina, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Canada, Central African Republic, Chile, China, Colombia, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Cyprus, Czech Republic, Democratic People's Republic of Korea, Denmark, Dominica, Dominican Republic, Ecuador, Egypt, El Salvador, Ethiopia, Finland, France, Gabon, Gambia, Germany, Georgia, Grenada, Guatemala, Guyana, Honduras, Hungary, Iceland, Indonesia, Iran (Islamic Republic of), Ireland, Israel, Italy, Jamaica, Japan, Jordan, Kazakhstan, Kuwait, Lao People's Democratic Republic, Latvia, Liberia, Libyan Arab Jamahiriya, Liechtenstein, Lithuania, Luxembourg, Madagascar, Malawi, Malaysia, Maldives, Mali, Malta, Marshall





Islands, Mauritius, Monaco, Mongolia, Morocco, Mozambique, Myanmar, Namibia, Netherlands, New Zealand, Norway, Oman, Pakistan, Palau, Panama, Papua New Guinea, Paraguay, Peru, Poland, Portugal, Republic of Korea, Romania, Russian Federation, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Samoa, San Marino, Saudi Arabia, Senegal, Serbia, Singapore, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sudan, Suriname, Sweden, Switzerland, Syrian Arab Republic, Thailand, the former Yugoslav Republic of Macedonia, Timor-Leste, Togo, Tonga, Trinidad and Tobago, Tunisia, Turkmenistan, Uganda, Ukraine, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America, Uruguay, Uzbekistan, Vanuatu, Yemen and Zambia.

- 6. As indicated in paragraph 2 of the Secretary-General's memorandum, information concerning the appointment of their representatives to the sixty-fifth session of the General Assembly had been communicated to the Secretary-General, by means of a facsimile communication from the Head of State or Government or Minister for Foreign Affairs or by means of a letter or note verbale from the Permanent Mission concerned, by the following 55 Member States: Antigua and Barbuda, Belgium, Belize, Bolivia (Plurinational State of), Botswana, Burundi, Cambodia, Cameroon, Cape Verde, Chad, Comoros, Congo, Democratic Republic of the Congo, Djibouti, Equatorial Guinea, Eritrea, Estonia, Fiji, Ghana, Greece, Guinea, Guinea-Bissau, Haiti, India, Iraq, Kenya, Kiribati, Kyrgyzstan, Lebanon, Lesotho, Mauritania, Mexico, Micronesia (Federated States of), Montenegro, Nauru, Nepal, Nicaragua, Niger, Nigeria, Philippines, Qatar, Republic of Moldova, Rwanda, Sao Tome and Principe, Seychelles, Sierra Leone, Solomon Islands, Somalia, Swaziland, Tajikistan, Turkey, Tuvalu, Venezuela (Bolivarian Republic of), Viet Nam and Zimbabwe.
- 7. On 22 December 2010, the Secretary-General submitted to the Committee an updated version of the credentials of the representatives of Côte d'Ivoire in the form required by rule 27 of the rules of procedure of the General Assembly. The Committee met on the same day and took note of the decision of the African Union, taken on 9 December 2010, to recognize the results proclaimed by the Independent Electoral Commission and Mr. Alassane Ouattara as President Elect of Côte d'Ivoire. The Committee accepted the updated version of the credentials of the representatives of Côte d'Ivoire, dated 22 December 2010. The Committee confirmed that the resolution adopted in paragraph 8 of its report is understood to apply to the updated version of the credentials of the representatives of Côte d'Ivoire.
- 8. The Chair proposed the following draft resolution for adoption by the Committee:

The Credentials Committee,

Having examined the credentials of the representatives to the sixty-fifth session of the General Assembly of the Member States referred to in paragraphs 5 to 7 of the report of the Credentials Committee,

Accepts the credentials of the representatives of the Member States concerned.

9. The draft resolution proposed by the Chair was adopted without a vote.

- 10. The Chair then proposed that the Committee recommend to the General Assembly the adoption of a draft resolution entitled "Credentials of representatives to the sixty-fifth session of the General Assembly" (see para. 12). The proposal was adopted without a vote.
