

Note by the Secretary-General

- 1. The fourth session of the Committee on the Rights of Persons with Disabilities will be held at the United Nations Office at Geneva from 4 to 8 October 2010. The first meeting of the session will be convened on Monday 4 October at 10 a.m.

1. Adoption of the agenda

Under rule 9 of the Committee's rules of procedure (CRPD/C/3), the first item on the agenda of any session shall be the adoption of the agenda, unless the election of officers is required under rule 20. In accordance with rule 10, the Committee may revise the agenda during a session and may, as appropriate, defer or delete items.

2. Organizational matters

Under this item, the Committee shall consider matters concerning the organization of the current session, in particular the adoption of its programme of work.

3. Adoption of the report of the third session of the Committee

Under this item, the Committee will adopt the report of the third session of the Committee.

5. Adoption of lists of issues on State party reports

Under this item, the Committee will adopt a list of issues on the initial report submitted by Tunisia.

6. Cooperation with other United Nations bodies, specialized agencies and other competent bodies

Under this item, the Committee will pursue its discussion on how existing cooperation with various relevant bodies could be further strengthened to enhance the promotion and protection of the rights of persons with disabilities.

7. Methods of work of the Committee

Under this item, the Committee will pursue its discussion concerning the organization of its future work, as well as the procedure to be followed in considering reports by States parties and their follow-up, including, where necessary, areas identified for technical assistance. The Committee will also discuss the recommendations emanating from the twenty-second meeting of chairpersons of the human rights treaty bodies (1–2 July 2010) and the eleventh inter-committee meeting (28–30 June 2010).

8. Day of general discussion

Under this item, the Committee will hold a day of general discussion on article 9 of the Convention concerning accessibility.

9. Future meetings

Under this item, the Committee will be informed of any developments relating to its future meetings.

10. Other matters

Under this item, the Committee will discuss such other matters relating to the work of the Committee as may be necessary.
