Steps that have been taken by the Government of Jordan respecting implementation of Security Council resolution 1929 (2010)

This report is in follow-up to previous reports submitted by the Government of Jordan respecting implementation of Security Council resolutions 1737 (2006), 1747 (2007) and 1803 (2008).

Set forth below is a review of the steps that have been taken by the Government of Jordan respecting implementation of Security Council resolution 1929 (2010):

1. Security Council resolution 1929 (2010), paragraph 31, contains additions to the operative paragraphs with which compliance is requested in Security Council resolutions 1737 (2006), 1747 (2007) and 1803 (2008). The Government of Jordan has issued its instructions to the bodies and institutions responsible for implementing all the requirements made in the aforementioned resolutions, including the most recent additions. Details are set forth in paragraphs 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 21, 22, 23 and 24 of resolution 1929 (2010).

2. The Government of Jordan has circulated the substance of resolution 1929 (2010) to the relevant official bodies and institutions, including financial institutions, and, with a view to ensuring implementations of the pertinent obligations, has explained the requirements and the additions to the earlier, above-mentioned resolutions.

3. Within their spheres of specialization, the relevant Jordanian bodies and institutions are following up implementation of the requirements of resolutions 1737 (2006), 1747 (2007), 1803 (2008) and 1929 (2010). Activities include the following:

- (a) State control over investment in its territory.
- (b) Control of the import of arms and related materiel and prevention of the sale, transference or supply thereof to Iran.
- (c) Control of land, air and sea borders and prevention of the entry into the country of individuals who are named in the annexes to the above-mentioned resolutions.
- (d) Control of the movements of means of land, air and sea transport, in order to implement the above-mentioned Security Council resolutions.
