## Letter dated 24 May 2011 from the Permanent Representative of Cambodia to the United Nations addressed to the President of the Security Council

With reference to the recommendation of the United Nations Security Council of 14 February 2011, concerning the armed conflict at the Cambodia-Thailand border, I have the honour to bring to your kind attention the following developments:

Since the informal ASEAN Foreign Ministers' Meeting in Jakarta on 22 February 2011, Indonesia, as Chair of ASEAN, has presented a total of seven drafts of the terms of reference for the deployment of the Indonesian Observers Team to the affected areas of the Cambodia-Thailand border.

Cambodia has given its immediate and positive response to each of these drafts, and already signed the letter of acceptance to put the terms of reference into effect on 3 May 2011. Thailand, however, has not so far given its acceptance of the terms of reference.

As a further effort to speed up the deployment of the Indonesian Observers Team to observe the commitment of both sides to avoid further armed clashes and engender a permanent ceasefire, a trilateral meeting of the Foreign Ministers of Cambodia, Indonesia and Thailand was convened in Jakarta on 9 May 2011 by the Minister for Foreign Affairs of Indonesia, Chair of ASEAN.

At that meeting the Ministers concurred to positively recommend a package of resolutions to their respective governments as stated in the attached agreed summary of the meeting (annex I). Through three successive letters, herewith attached, Cambodia positively responded and confirmed its full acceptance of the package of resolutions (annexes II to IV). Thailand, however, has not given its positive reply until now, in spite of three successive reminder letters from the Indonesian Foreign Minister, herewith attached (annexes VII to IX).

I should be grateful if the present letter and its annexes could be circulated to all members of the Security Council as a document of the Security Council.

#### AGREED SUMMARY

Meeting of the Deputy Prime Minister, Minister for Foreign Affairs and International Cooperation of Kingdom of Cambodia, H.E. Hor Namhong, the Minister of Foreign Affairs of the Kingdom of Thailand, H.E. Kasit Piromya, and the Minister of Foreign Affairs of the Republic of Indonesia, H.E. R.M. Marty M. Natalegawa in Jakarta on 9 May 2011

- As a follow-up to the meeting of the Prime Minister of the Kingdom of Cambodia, H.E. Samdech Hun Sen, the Prime Minister of the Kingdom of Thailand, H.E. Abhisit Vejiajiva, and the President of the Republic of Indonesia, H.E. Susilo Bambang Yudhoyono, the Deputy Prime Minister, Minister for Foreign Affairs and International Cooperation of Kingdom of Cambodia, H.E. Hor Namhong, the Minister of Foreign Affairs of the Kingdom of Thailand, H.E. Kasit Piromya, and the Minister of Foreign Affairs of the Republic of Indonesia, H.E. R.M. Marty M. Natalegawa, met in Jakarta, on 9 May 2011.
- Following the discussion, they reaffirm the Statement of the Chair of ASEAN following the Informal Meeting of the Foreign Ministers of ASEAN on 22 February 2011 and the Chairman Statement of the 18<sup>th</sup> ASEAN Summit 8 May 2011, as follows:

"We emphasized the underlying norm and principle of ASEAN that differences between ASEAN Member States should be amicably resolved in the spirit of ASEAN Solidarity, in accordance with the principles contained in the Treaty of Amity and Cooperation in Southeast Asia (TAC) and the ASEAN Charter

We welcomed Cambodia's and Thailand's commitment to peacefully resolve their differences through political dialogue and negotiations with a view to achieving mutually acceptable solution through the fullest utilization of their existing bilateral mechanism, with appropriate engagement of Indonesia, current Chair of ASEAN. In this regard, we appreciate that Cambodia and Thailand have agreed on the text of the Terms of Reference (TOR) on the Indonesian Observers Team (IOT) in the affected areas following the incidents in February 2011 and encourage the attainment of an environment conducive to their assignment We also expressed our appreciation and support for the continuing effort of Indonesia, current Chair of ASEAN, to facilitate the process through its appropriate engagement which would help advance our collective efforts to attain the ASEAN Community." In pursuit of the above, and in accordance with the task set by the Leaders at their aforementioned meeting on 8 May 2011, the Foreign Ministers concurred on a package of solutions, with appropriate timeline, as below:

Exchange of letter on IOT TOR
Announcement of GBC/JBC Meetings Timeline: "D"

Dispatch of IOT survey team

Meetings of the GBC/JBC Timeline : "D + 5 "

Full assignment of IOT

Follow-up on results of GBC/JBC Timeline: "D + 10 "


In this regard, I am pleased to inform you that the Royal Government of Cambodia accepts in full the content of the above Agreed Summary.

I would like to share some preliminary thoughts: First, *identical* draft of the letter of acceptance has been considered and agreed to by both Cambodia and Thailand Indeed, in the case of Cambodia, this agreed letter of acceptance has been formally sent to the Government of Indonesia on 3 May 2011. Thus, to amend the letter of acceptance at this stage would also have an impact on the nature of the acceptance by Cambodia

Second, the proposed amendments from Thailand to the letter of acceptance appear to relate to issues that we have agreed to address through the package solutions approach as indicated in the Agreed Summary that we plan to submit to our governments with positive recommendation. In other words, while they are related to the operationalization of the TOR, they are not strictly speaking related to the coming into effect of the TOR.
