Letter dated 28 May 2011 from the Permanent Representative of Armenia to the United Nations addressed to the Secretary-General

I would like to draw your attention to document A/65/847-S/2011/325 of 23 May 2011, containing a letter from the Permanent Representative of Azerbaijan. It represents yet another example of an ongoing anti-Armenian propaganda campaign which is irresponsible and deplorable.

It is truly disappointing that, given the important agenda of the sixty-fifth session of the General Assembly, Azerbaijan continues to abuse its privilege of being a State Member of the United Nations by using every opportunity presented to it as such to falsely discredit Armenia and Nagorno-Karabakh. The propagandist purpose of that letter is further evident from the fact that Azerbaijan chose the United Nations as a forum for the circulation of its disinformation.

As in the past, the above-mentioned letter of the Azerbaijani representative goes through the cherry-picking exercise of highlighting only what is convenient for its propaganda purposes. Azerbaijan, rather than using the findings and the recommendations of the Organization for Security and Cooperation in Europe (OSCE) Minsk Group Co-Chairs presented on the basis of their Field Assessment Mission to further the peace process and promote constructive discussions among the parties to the conflict, is attempting to misinform the international community about the report, disrespecting and undermining the hard work and the efforts of the OSCE Minsk Group Co-Chairs.

Moreover, the proposals and statements voiced by the United Nations Secretary-General, the OSCE Chairman-in-Office, the Minsk Group Co-Chair





countries and the leadership of the European Union on the consolidation of the ceasefire and the withdrawing of snipers from the line of contact are being not only ignored but also mocked in Azerbaijan at the highest level. Just on 20 May, the Azerbaijani Foreign Minister stated that the proposal on the withdrawing of snipers from the line of contact was "ridiculous".

We do hope that Azerbaijan, instead of circulating baseless and provocative letters, will concentrate on the ongoing OSCE Minsk Group negotiation process.

Armenia highly appreciates the efforts of the OSCE Minsk Group Co-Chair countries directed at the peaceful settlement of the Nagorno-Karabakh conflict. The statement made on 26 May 2011 on the sidelines of the G-8 Summit in Deauville by the leaders of the OSCE Minsk Group Co-Chair countries contains important messages and may become an impulse for the settlement of the issue.

Armenia has always been in support of the settlement of the conflict between Azerbaijan and Nagorno-Karabakh exclusively by peaceful means and has repeatedly proved that in practice. Armenia has given a clear response to the latest version of the basic principles proposed by the three Co-Chairs as a basis for the negotiation of the settlement. If Azerbaijan gives an unequivocal agreement for the same, then it will be possible to register progress in the process of the settlement.

I should be grateful if you would have the present letter, and its annex on the ceasefire violations during the period from 1 April to 1 May 2011, circulated as a document of the General Assembly, under agenda items 34, 39, 66 and 75, and of the Security Council.
