ADMINISTRATIVE INSTRUCTION

To: Executive Officers and Administrative Officers

Subject: CERTIFYING OFFICERS - 1968 ACCOUNTS

A. Designation of Certifying Officer

- 1. The attached list enumerates the officers designated by the Controller, in terms of Financial Rule 110.4, as Certifying Officers and Alternate Certifying Officers in respect of the 1968 accounts as indicated. ST/AI/171 and all amendments thereto are hereby cancelled.
- 2. Certifying Officers and their Alternates administered by the United Nations Office at Geneva will be designated by the Director-General of that office.
- 3. Any change in the present list which may become necessary in the course of 1968 shall be the subject of a written recommendation by the Head of the Department or Office to the Controller for his approval. Notification of approved changes will be issued in the form of amendments to this Instruction.

B. Functions of a Certifying Officer

- 4. The responsibility attached to the position of Certifying Officer or Alternate Certifying Officer is a personal one and cannot be delegated.
- 5. The functions of such an Officer are to certify that a proposed obligation or expenditure:
 - (a) Is in accord with existing regulations, rules and instructions;
- (b) Is reasonable and in accord with the purpose for which the relevant appropriation was approved and the allotment made;
- (c) Can be met from the available balance of the allotment to the relevant account, with due regard to foreseeable future obligations.

- 6. In the case of expenditure accounts for established posts and for the related common staff costs, the certification shall refer to adherence to authorized manning tables, to entitlements established by the Office of Personnel and to time and attendance rather than to the availablilty of funds. Certification of all other staff costs such as temporary assistance, consultants and experts, travel of staff shall refer to time and attendance, where applicable, as well as to the availability of funds within allotments or other forms of authorization (e.g., temporary assistance authorizations, MOD's, etc.).
- 7. On all occasions a Certifying Officer shall ensure that proposed obligations or expenditures are properly classified and coded in accordance with the 1968 codes in the Allotment Account Codes Handbook (ST/ADM/L.3/Rev.8).
- 8. An Alternate Certifying Officer is personally responsible for his actions while deputizing for the Certifying Officer. For ensuring that total obligations and expenditures remain within the allotments, it is incumbent on the Certifying Officer to take into account the prior actions of his Alternate.
- 9. Should any question arise in connexion with a proposed obligation or expenditure, the Certifying Officer may, if he considers this necessary, request the written instruction of the Head of his Department or other officer to whom the latter has delegated the required authority. If the Certifying Officer is then instructed to certify, responsibility for the action taken will rest with the Officer issuing the instruction and the Certifying Officer should qualify his certification to that effect.
- 10. The function performed by a Certifying Officer is antecedent to and distinct from that of the appropriate Approving Officer, designated by the Controller, in terms of Financial Rule 108.9, to approve actual payments on behalf of the Organization.
- 11. In terms of Financial Rule 110.3 the Controller and Deputy Controller have the authority to certify obligations and expenditures under all accounts.
