Report of the Fifth Committee (Part I)

- 1. At its 3rd plenary meeting, on 21 September 1984, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its thirty-ninth session the item entitled "Report of the Economic and Social Council". At the same meeting, the Assembly decided to allocate chapters I, III (part I, sect. B, and part II, sect. F), V (sect. C), VI (sect. C), VIII and IX (part I, sects. C, F, G, I and O, and part II, sects. F and G) 1/ to the Fifth Committee.
- 2. The Fifth Committee considered chapter V (sect. C) of the report of the Economic and Social Council at its 16th meeting, on 24 October 1984. It had before it, in addition to the report of the Economic and Social Council, a note by the Secretary-General (A/39/511) transmitting the text of the statute of the International Research and Training Institute for the Advancement of Women which the Council, in its decision 1984/124 of 24 May 1984, had approved and decided to transmit to the General Assembly for its endorsement, as well as a report thereon

by the Advisory Committee on Administrative and Budgetary Questions (A/39/568). At the same meeting, the Fifth Committee decided, without objection, to recommend to the General Assembly that it adopt a draft resolution orally proposed by its Chairman (see para. 4).

3. The comments and observations made in the course of the consideration of this topic are reflected in the summary record of the Fifth Committee (A/C.5/39/SR.16).

RECOMMENDATION OF THE FIFTH COMMITTEE

4. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:
