FOREWORD

The financial regulations adopted by the General Assembly provide that "the annual budget estimates . . . shall be accompanied by such information annexes and explanatory statements as may be requested by, or in behalf of the General Assembly, and such further annexes or statements as the Secretary-General may deem necessary and useful". (Article 3.3 of the Financial Regulations, resolution 456 (V).)

As in past years, therefore, this information annex is presented by the Secretary-General in order to assist the General Assembly in considering the budget estimates for 1953 and in reviewing the budget appropriations or estimates of the specialized agencies.

The annex contains information in respect of the budgets or appropriations of the following agencies: International Labour Organisation; Food and Agriculture Organization; United Nations Educational, Scientific and Cultural Organization; International Civil Aviation Organization; Universal Postal Union; World Health Organization; International Telecommunication Union; and World Meteorological Organization.

In the case of the Universal Postal Union, the only information received at the time of preparation of this annex consisted of provisional figures related to the 1953 estimates of the Union. The International Bank for Reconstruction and Development and the International Monetary Fund, under the terms of their relationship agreements, do not submit their administrative budgets to the United Nations.

The contents of this annex are divided into four parts: (a) analysis of United Nations and specialized agencies budget appropriations or estimates by standard objects of expenditure; (b) analysis of United Nations and specialized agency budget appropriations or estimates by main activities (project estimates); (c) analysis of the financial status of the United Nations and the specialized agencies; and (d) statement of extra-budgetary funds administered by the United Nations and the specialized agencies in respect of economic and social activities.

The present information annex represents the fourth submission of composite documentation on the expenditures of the United Nations and most of its specialized agencies. With each succeeding submission the material put forward to the General Assembly in this annex has improved in comparability at the same time that it has increased in quantity. In view of the addition to the annex of an analysis of estimates by main fields of activity, the necessity for continuing, in its present form, the detailed enumeration of budget amounts by standard objects of expenditure becomes questionable; guidance from the General Assembly on this subject would be appreciated.

STANDARD SUMMARY OF BUDGETS

The standard summary of 1952 budget appropriations and 1953 budget appropriations or estimates is

set out in table B of part I. In addition a consolidated presentation of these data showing the total sums involved for all reporting organizations is given for the first time in table A.

The form of the standard summary is the same as that used last year. It follows the common panel of objects of expenditure agreed upon by the Consultative Committee on Administrative Questions, a basic distinction being made between "Meetings" and "Secretariat" expenditures.

The details of these summaries relate as usual to the "regular" administrative budgets of the organizations. Information on costs relating to extra-budgetary programmes, including the expanded programme of Technical Assistance, is given in part IV of this annex.

ESTABLISHED POSTS

In addition to the standard summary of budgets by objects of expenditure, part I of this annex contains a schedule of established posts provided for in the administrative budgets of the United Nations and the specialized agencies for the years 1951, 1952, and 1953, as well as a schedule showing the location of staff for which provision is made in the 1953 budget.

SUMMARY OF MAIN ACTIVITIES (PROJECT ESTIMATES)

In accordance with paragraph 4 of General Assembly resolution 413 (V) an analysis of the budget appropriations or estimates for 1953 by main activities is given as part II of this annex. Data are presented for the United Nations and for the following specialized agencies: International Labour Organisation; Food and Agriculture Organization; United Nations Educational, Scientific and Cultural Organization; International Civil Aviation Organization; World Health Organization; International Telecommunication Union; and World Meteorological Organization.

It has been possible this year, with the co-operation of the participating organizations, to obtain a greater uniformity in the breakdown of main activities used. As a consequence, a composite presentation summarizing this material for all agencies is presented as table D. The individual analyses of main fields of activities for each organization appear in tables E through L.

An explanation of the methods followed in preparation of this summary is given as the opening statement of part II.

SUMMARY OF FINANCIAL STATUS OF ORGANIZATIONS

The status of receipt of contributions by the United Nations and certain of the specialized agencies as at 31 August 1952 is to be found in table N of part III of this annex.

Part III also contains, in table M, a standard summary of the financial status of the organizations for the

years 1950 and 1951. The practice of including such a standard summary was inaugurated last year.

SUMMARY OF EXTRA-BUDGETARY FUNDS

Material on extra-budgetary funds is again included as suggested by the Administrative Committee on Co-ordination which believed that such summary data would be useful to the General Assembly, in view of the concerns of the Assembly expressed in resolution

411 (V). The summary statement appears at
of this annex.

RELATED DOCUMENTATION

It is to be noted that the 1953 budget of the specialized agencies will be the subject of a report by the Advisory Committee on Administration and Budgetary Questions in accordance with the reference.

PART II

Analysis of United Nations and specialized agencies budget appropriations or estimates for 1953 by main activities (project estimates)

Introductory

In its introduction to part II, the Information Annex II to Budget Estimates for the Financial Year 1952 (supplement 5A, A/1812/Add.1) states the references under which the information contained therein is produced, as well as the methods used in its compilation.

Continuing to assume that the General Assembly is interested in an analysis by various types of activity rather than by individual work assignments, no important changes have been made in the similar presentation of 1953 figures. However, in the light of experi-

ence gained, further efforts have been directed towards greater uniformity for comparative purposes. The following specialized agencies have contributed to this end: ILO, FAO, UNESCO, ICAO, WHO, ITO and WMO.

Meanwhile, discussions between the United Nations and the specialized agencies are continuing to provide in future years comparative tables to be derived from an even more uniform application of mutually agreed upon general principles.
