APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

Appointment of members of the Advisory Committee on Administrative and Budgetary Questions

Report of the Fifth Committee

Rapporteur: Mr. Ali Achraf MOJTAHED (Islamic Republic of Iran)

1. At its 39th meeting, on 30 November 1984, the Fifth Committee considered a note by the Secretary-General (A/39/101) concerning the vacancies in the membership of the Advisory Committee on Administrative and Budgetary Questions which will occur as a result of the expiration of the term of office of five of its members on 31 December 1984.
2. The Fifth Committee also had before it a note by the Secretary-General (A/C.5/39/48) containing the names of six persons nominated by their respective Governments for appointment to the Advisory Committee.
3. The Fifth Committee decided by acclamation to recommend the appointment to the Advisory Committee on Administrative and Budgetary Questions, for a three-year term beginning on 1 January 1985, of Mr. Even Fontaine-Ortiz (Cuba), Mrs. Virginia Housholder (United States of America), Mr. Igor V. Khalevinskiy (Union of Soviet Socialist Republics) and Mr. Rachid Lahlou (Morocco).
4. The Fifth Committee then proceeded to elect by secret ballot one person to fill the remaining vacancy. The result of the voting was as follows:
