

Construction of additional office facilities at the United Nations Office at Nairobi

Report of the Secretary-General

Summary

Pursuant to section I of General Assembly resolution 63/263, in which the Assembly endorsed the conclusions and recommendations of the Advisory Committee on Administrative and Budgetary Questions (A/63/465), progress reports are to be submitted annually to the Assembly for all ongoing construction projects.

The present report provides an update on the successful completion of the construction of additional office facilities at the United Nations Office at Nairobi.

I. Completion of construction

- 1. Construction of the new office facility at the United Nations Office at Nairobi commenced on 4 May 2009 with a scheduled substantial completion date in December 2010. The construction contract will be completed after the final payments are made in June 2012.
- 2. Construction of the new office facility was finished on time and substantial completion was achieved at the end of December 2010.
- 3. As envisaged by the Secretary-General in his report to the sixty-fifth session of the General Assembly (A/65/351), the work on internal office partitioning began in September 2010. According to the original schedule, partitioning work was to commence in early 2011, and occupation of the new office facility was to be completed by June 2011. The actual rate of work resulted in the completion of internal partitioning by March 2011 and allowed for occupancy of the building earlier than anticipated.
- 4. The United Nations Environment Programme (UNEP) moved into the new office facility during January and the first half of February 2011. This involved relocating approximately 550 staff members to the new building within one month, prior to the twenty-sixth session of the UNEP Governing Council, held from 21 to 25 February 2011.
- 5. The United Nations Human Settlements Programme (UN-Habitat) was also successfully moved into the new building during February and March 2011.
- 6. The formal inauguration of the new office facility took place on 31 March 2011 and was presided over by the Secretary-General and the President of Kenya.
- 7. Once UNEP and UN-Habitat vacated their original offices, the United Nations Office at Nairobi began reallocating those offices to other United Nations agencies, funds and programmes that had insufficient office space in the United Nations complex or were renting commercial office space outside the complex. The reallocation of these offices began in early 2011; by the end of June 2011 a significant number of moves had been completed.

II. Project schedule

8. The project schedule is shown in table 1. The construction was completed on schedule at the end of 2010. The internal partitioning and outfitting component was completed well ahead of schedule and the new building was fully occupied by the end of March 2011, as described above.



III. Cost estimates

9. The latest project cost estimates are summarized in table 2. A detailed breakdown with cash flow requirements during the period 2010 to 2012 is provided in the annex.

10. As shown in table 2, the total cost of the project remains at \$25,252,200, as approved by the General Assembly in 2009. The cost breakdown, however, was altered as a result of the changes that occurred during the construction phase. The

only significant change reflected in the above table relates to the increase of architects' fees owing to the increase in construction costs.

11. The final cost of the project will be determined at the time of issuance of the final payments in June 2012. Given the cost of the project to date and the latest trend in exchange rate fluctuations, it is likely that at least part of the contingency will be released (i.e. the new office facility construction project at the United Nations Office at Nairobi may be completed below the approved budget). This matter will be discussed in a report to the General Assembly at its sixty-seventh session.

IV. Actions to be taken by the General Assembly

12. The General Assembly is requested to take note of the report.
