I. Opening of the session

1. The thirty-fourth session of the Subsidiary Body for Scientific and Technological Advice (SBSTA) was held at the Maritim Hotel, Bonn, Germany, from 6 to 16 June 2011.

2. The Chair of the SBSTA, Mr. Mama Konaté (Mali), opened the session and welcomed all Parties and observers. He also welcomed Mr. Mihir Kanti Majumder (Bangladesh) as Vice-Chair of the SBSTA and Mr. Purushottam Ghimire (Nepal) as Rapporteur.

3. At its 1^{st} meeting, on 6 June, Parties considered a note by the Executive Secretary, containing the provisional agenda and annotations, and the supplementary provisional agenda, contained in document FCCC/SBSTA/2011/1 and Add.1 and 2.

4. At its 2^{nd} meeting, on 9 June, the SBSTA considered a proposal by the Chair containing a provisional agenda (FCCC/SBSTA/2011/L.1).

5. At the same meeting the SBSTA adopted items 1 to 12 of the provisional agenda proposed by the Chair (FCCC/SBSTA/2011/L.1). The Chair proposed, and the SBSTA agreed, that he would hold consultations with interested Parties on items 13, 14 and 15(a) and (b) of the provisional agenda contained in document FCCC/SBSTA/2011/L.1, and report back to Parties on progress made.

- 9. Methodological issues under the Convention:
 - (a) Emissions from fuel used for international aviation and maritime transport;
 - (b) Revision of the UNFCCC reporting guidelines on annual inventories for Parties included in Annex I to the Convention;
 - (c) Greenhouse gas data interface.
- 10. Methodological issues under the Kyoto Protocol:
 - Implications of the establishment of new hydrochlorofluorocarbon-22 (HCFC-22) facilities seeking to obtain certified emission reductions for the destruction of hydrofluorocarbon-23 (HFC-23);
 - (b) Materiality standard under the clean development mechanism;
 - (c) Common metrics to calculate the carbon dioxide equivalence of greenhouse gases.
