

Addendum

- 1. The International Convention for the Protection of All Persons from Enforced Disappearance ("the Convention") entered into force on 23 December 2010. In accordance with article 26 of the Convention, the first meeting of States Parties to the Convention is scheduled to be convened at the United Nations Headquarters, for the purpose of electing of 10 members of the Committee on Enforced Disappearances ("the Committee") from a list of persons nominated by States Parties from among their nationals.
- 2. In accordance with article 26, paragraph 3, of the Convention, the Secretary-General, in a note verbale dated 7 January 2011, invited the States parties to submit their nominations for the election of members of the Committee by 7 April 2011. Information on seven persons nominated is contained in CED/SP/1/2. Three additional nominations, received after 7 April 2011, are as follows: Mamadou Badio Camara (Senegal), Juan José López Ortega (Spain) and Enoch Mulembe (Zambia).
- 3. The curricula vitae of the above-mentioned candidates, as furnished by their Governments, are attached (see annex).
