## Security Council Committee established pursuant to resolution 1970 (2011) concerning the Libyan Arab Jamahiriya

## Note verbale dated 30 June 2011 from the Permanent Mission of Slovenia to the United Nations addressed to the Chair of the Committee

The Permanent Mission of the Republic of Slovenia to the United Nations has the honour to submit a national report on the implementation of the restrictive measures against Libya imposed by the Security Council in its resolutions 1970 (2011) and 1973 (2011).

## National report by the Republic of Slovenia on the implementation of the restrictive measures against Libya imposed by the Security Council in its resolutions 1970 (2011) and 1973 (2011)

The Republic of Slovenia and the other member States of the European Union have jointly implemented the restrictive measures against Libya imposed by the Security Council in its resolutions 1970 (2011) and 1973 (2011) by taking the following common measures:<sup>1</sup>

• Council decision 2011/137/CFSP of 28 February 2011 concerning restrictive measures in view of the situation in Libya as amended by Council decision 2011/178/CFSP of 23 March 2011 and Council decision 2011/332/CFSP of 7 June 2011.

The Council decision set out the European Union's commitment to implementation of all the measures contained in Security Council resolutions 1970 (2011) and 1973 (2011), and provides the basis for European Union specific accompanying measures within the scope of the resolutions, notably:

- Export ban on equipment which might be used for internal repression
- Autonomous designations under the visa ban and the asset freeze, to be decided by the Council of the European Union, of persons and entities involved in serious human rights abuses in Libya, including by being involved in attacks, in violation of international law, on civilian population and facilities
- Council regulation 204/2011 of 2 March 2011 concerning restrictive measures in view of the situation in Libya as amended by Council regulation 296/2011 of 25 March 2011 and Council regulation 572/2011 of 16 June 2011.

The Council has adopted a Council regulation in order to implement the measures provided for in Council decision 2011/137/CFSP which fall under the competence of the Union.

• Council decisions implementing Council decision 2011/137/CFSP and Council regulations implementing Council regulation 204/2011.

The Council adopted a number of implementing decisions (Council decisions 2011/156/CFSP, 2011/175/CFSP, 2011/236/CFSP, 2011/300/CFSP and 2011/345/CFSP) and regulations (Council regulations 233/2011, 272/2011, 288/2011, 360/2011, 502/2011 and 573/2011) in order to include additional persons and entities in the list of persons and entities subject to European Union autonomous restrictive measures.

• Council regulation 539/2001 of 15 March 2001 (and its subsequent amendments).

This regulation requires nationals of Libya to be in possession of a visa when entering the European Union.

As a European Union member State and in line with the said European Union legal instruments, the Republic of Slovenia adopted national legislation for the implementation of the said resolutions. Thus, in accordance with the Act Relating to Restrictive Measures Introduced or Implemented in Compliance with Legal Instruments and Decisions adopted within International Organisations (OJ RS No. 127/2006), Slovenia adopted the Decree on restrictive measures against Libya and on implementation of Council regulation 204/2011 (OJ RS No. 37/2011).
