

Implementation of the Declaration of the Indian Ocean as a Zone of Peace

Report of the First Committee

I. Introduction

- 1. The item entitled "Implementation of the Declaration of the Indian Ocean as a Zone of Peace" was included in the provisional agenda of the sixty-sixth session of the General Assembly in accordance with Assembly resolution 64/23 of 2 December 2009.
- 2. At its 2nd plenary meeting, on 16 September 2011, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.
- 3. At its 3rd meeting, on 3 October 2011, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 87 to 106. The general debate on those items was held at the 3rd to 9th meetings, from 3 to 7 and on 10 and 11 October (see A/C.1/66/PV.3-9). The Committee also held 11 meetings, from 12 to 14, from 17 to 21 and on 24 and 25 October, for an exchange of views with the High Representative for Disarmament Affairs and other high-level officials, as well as panel discussions with independent experts and follow-up to resolutions and decisions adopted at previous sessions (see A/C.1/66/PV.10-20). Thematic discussions on the items were held, and draft resolutions were introduced and considered, at the 10th to 20th meetings, from 12 to 14, from 17 to 21 and on 24 and 25 October (see A/C.1/66/PV.10-20). Action on all draft resolutions and decisions was taken at the 21st to 24th meetings, from 26 to 28 and on 31 October (see A/C.1/66/PV.21-24).
- 4. No documents were submitted for consideration under this item.





II. Consideration of draft resolution A/C.1/66/L.5

- 5. At the 18th meeting, on 21 October, the representative of Indonesia, on behalf of the States Members of the United Nations that are members of the Movement of Non-Aligned Countries, introduced a draft resolution entitled "Implementation of the Declaration of the Indian Ocean as a Zone of Peace" (A/C.1/66/L.5).
- 6. At its 21st meeting, on 26 October, the Committee adopted draft resolution A/C.1/66/L.5 by a recorded vote of 124 to 4, with 45 abstentions (see para. 7). The voting was as follows: 1

III. Recommendation of the First Committee

7. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

Implementation of the Declaration of the Indian Ocean as a Zone of Peace

The General Assembly,

Recalling the Declaration of the Indian Ocean as a Zone of Peace, contained in its resolution 2832 (XXVI) of 16 December 1971, and recalling also its resolutions 54/47 of 1 December 1999, 56/16 of 29 November 2001, 58/29 of 8 December 2003, 60/48 of 8 December 2005, 62/14 of 5 December 2007 and 64/23 of 2 December 2009 and other relevant resolutions,

Recalling also the report of the Meeting of the Littoral and Hinterland States of the Indian Ocean held in New York from 2 to 13 July 1979, ¹

Recalling further paragraph 102 of the Final Document of the Thirteenth Conference of Heads of State or Government of Non-Aligned Countries, held at Kuala Lumpur on 24 and 25 February 2003,² in which it was noted, inter alia, that the Chair of the Ad Hoc Committee on the Indian Ocean would continue his informal consultations on the future work of the Committee,

Emphasizing the need to foster consensual approaches that are conducive to the pursuit of such endeavours,

Noting the initiatives taken by countries of the region to promote cooperation, in particular economic cooperation, in the Indian Ocean area and the possible contribution of such initiatives to overall objectives of a zone of peace,

Convinced that the participation of all permanent members of the Security Council and the major maritime users of the Indian Ocean in the work of the Ad Hoc Committee is important and would assist the progress of a mutually beneficial dialogue to develop conditions of peace, security and stability in the Indian Ocean region,

Considering that greater efforts and more time are required to develop a focused discussion on practical measures to ensure conditions of peace, security and stability in the Indian Ocean region,

Having considered the report of the Ad Hoc Committee on the Indian Ocean,³

- 1. Takes note of the report of the Ad Hoc Committee on the Indian Ocean;³
- 2. Reiterates its conviction that the participation of all permanent members of the Security Council and the major maritime users of the Indian Ocean in the work of the Ad Hoc Committee is important and would greatly facilitate the

development of a mutually beneficial dialogue to advance peace, security and stability in the Indian Ocean region;

- 3. *Requests* the Chair of the Ad Hoc Committee to continue his informal consultations with the members of the Committee and to report through the Committee to the General Assembly at its sixty-eighth session;
- 4. *Requests* the Secretary-General to continue to render, within existing resources, all necessary assistance to the Ad Hoc Committee, including the provision of summary records;
- 5. *Decides* to include in the provisional agenda of its sixty-eighth session the item entitled "Implementation of the Declaration of the Indian Ocean as a Zone of Peace".
