

2011 United Nations Pledging Conference for Development Activities

New York, 8 November 2011

Report of the 2011 United Nations Pledging Conference for Development Activities

A. Opening and duration of the session

- 1. By its resolution 45/215, the General Assembly decided, inter alia, that the adoption and signing of the Final Act of the United Nations Pledging Conference for Development Activities should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference was held at United Nations Headquarters on 8 November 2011.
- 3. The Conference was opened by the Acting Director, Office for Economic and Social Council Support and Coordination, Department of Economic and Social Affairs.

B. Attendance

- 4. The Conference was attended by representatives of the Governments of the following States: Afghanistan, Algeria, Australia, Bangladesh, China, Czech Republic, Democratic People's Republic of Korea, Djibouti, Egypt, Finland, Germany, India, Indonesia, Israel, Japan, Kuwait, Luxembourg, Malaysia, Monaco, Mongolia, Myanmar, New Zealand, Russian Federation, Saudi Arabia, Singapore, Thailand, Turkey, United Arab Emirates and Viet Nam.
- 5. Representatives of the following organs, organizations and bodies of the United Nations and the specialized and related agencies also attended the Conference: United Nations Children's Fund, United Nations Development Programme, Economic Commission for Africa, United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), United Nations Population Fund and World Food Programme.
