## **Eradication of poverty and other development issues**

### **Report of the Second Committee\***

1. At its 2nd plenary meeting, on 16 September 2011, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-sixth session the item entitled:

“Eradication of poverty and other development issues:

“(a) Implementation of the Second United Nations Decade for the Eradication of Poverty (2008-2017);

“(b) Women in development;

“(c) Human resources development”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 13th and 14th meetings, on 17 October 2011. An account of the Committee’s discussion of the item is contained in the relevant summary records (A/C.2/66/SR.13 and 14). Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, from 3 to 5 October (see A/C.2/66/SR.2-6).
