The President (*spoke in Russian*): As this is the first meeting of the Council for the month of December 2011, I should like to take this opportunity to pay tribute, on behalf of the Council, to His Excellency Mr. José Moraes Cabral, Permanent Representative of Portugal, for his service as President of the Security Council for the month of November 2011. I am sure I speak for all members of the Council in expressing deep appreciation to Ambassador Moraes Cabral and his delegation for the great diplomatic skill with which they conducted the Council's business last month.

The situation in Libya

Report of the Secretary-General on the United Nations Support Mission in Libya (S/2011/727)

The President (*spoke in Russian*): Under rule 37 of the Council's provisional rules of procedure, I invite the representative of Libya to participate in this meeting.

The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2011/752, which contains the text of a draft resolution submitted by France, Germany, Lebanon, Portugal, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

I wish to draw the attention of Council members to document S/2011/727, which contains the report of the Secretary-General on the United Nations Support Mission in Libya.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.

A vote was taken by show of hands.

In favour:

Bosnia and Herzegovina, Brazil, China, Colombia, France, Gabon, Germany, India, Lebanon, Nigeria, Portugal, Russian Federation, South Africa, United Kingdom of Great Britain and Northern Ireland and United States of America

The President (*spoke in Russian*): There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 2022 (2011).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda.
