Summary statement by the Secretary-General of matters of which the Security Council is seized and of the stage reached in their consideration

- 1. Pursuant to rule 11 of the provisional rules of procedure of the Security Council and the note by the President of the Security Council dated 26 July 2010 (S/2010/507), the Secretary-General is submitting the list of items of which the Security Council is currently seized. The last full list of items of which the Council is seized and which have been considered by the Council at a formal meeting since 1 January 2008 (S/2011/10/Add.48) was issued on 5 December 2011. The last weekly addendum (S/2011/10/Add.51) covered developments up to 24 December 2011.

Also pursuant to the note by the President, items 57 to 87 above are subject to deletion in 2012 because they have not been considered by the Council at a formal meeting during the three-year period from 1 January 2009 to 31 December 2011.
- 5. Pursuant to the procedure set out in the note by the President, the items identified in paragraph 4 above will be deleted unless a Member State notifies the President of the Security Council by 29 February 2012 that it wishes an item subject to deletion to remain on the list of matters of which the Security Council is seized, in which case such item will remain on the list for one year, unless the Council decides otherwise. The deletion of an item does not imply that such an item cannot be taken up by the Council as and when it deems necessary in the future.
- 6. The first addendum to this summary statement issued in February 2012 will contain a full, updated list of items of which the Security Council is seized, indicating those items considered by the Council at a formal meeting since 1 January 2008. Thereafter, the first addendum of each month to this summary statement will contain a full, updated list of items of which the Council is seized, indicating those items considered at a formal meeting since 1 January 2009. In intervening weeks, the Secretary-General, in fulfilment of his responsibility under rule 11 of the provisional rules of procedure of the Security Council, will issue a weekly addendum to the summary statement listing only those items on which further action was taken by the Council during the previous week or indicating that there was no change during that period.
- 7. The first addendum issued in March 2012 will indicate those items identified in paragraph 4 above as subject to deletion and which, at the request of a Member State, the Security Council has decided to retain for one year, and will also indicate those items identified in paragraph 4 which, in the absence of such a decision by the Council, have been deleted from the list.
