Follow-up to Economic and Social Council resolutions

Letter dated 21 November 2011 from the President of the Economic and Social Council to the Chair of the Commission on the Status of Women

This substantive session of the Economic and Social Council in July 2011 helped to highlight the need to advance the development goals related to education. By promoting consensus on issues including access to education, improving the delivery of education and learning outcomes and utilizing education resources to improve outcomes and quality, the Council has opened the way for a number of opportunities to promote improved global education. This is a major step forward and cuts to the heart of numerous education challenges.

The Council has set the stage for many follow-up actions leading to the development of regional action plans on education access and improvement. Strong support was expressed for establishing a global fund for education. This will certainly help us to realize the potential of the Council in generating momentum towards the achievement of the Millennium Development Goals through bringing together so many diverse constituencies on issues of global import and in encouraging innovative solutions to problems.

The Council also reviewed the follow-up by the United Nations system to the 2010 Ministerial Declaration on gender equality and the empowerment of women and to the International Conference on Financing for Development. The discussions underlined the demand for better global economic governance, particularly in regard to the role of the United Nations system and the linkages to the Group of 20.

The Council also, during its operational activities segment, voiced expectations that the 2012 quadrennial comprehensive policy review of the General Assembly would review progress in strengthening the United Nations resident coordinator system and strategize on ways to strengthen the funding architecture of funds and programmes through the definition of what constitutes a "critical mass" of

core resources.

The Council also demonstrated its capacity to react quickly on topical issues, including those of South Sudan and the current emergency situation in the Horn of Africa. It adopted a resolution that reaffirms the importance of access and humanitarian principles, cluster coordination and accountability.

Finally, an informal event on South Sudan held jointly with the Peacebuilding Commission showed the potential of the Council's role in addressing such situations. The Council will continue to monitor the development of the new country and its progress towards achieving the Millennium Development Goals in view of its special responsibility to ensure that the United Nations system support to the country is integrated and coordinated.

I would greatly appreciate it if the present letter and its annex could be brought to the attention of your functional commission for consideration and action, if necessary, and wish to thank you for your continued assistance and collaboration in that regard.
