**REPORT OF THE BOARD OF AUDITORS TO THE GENERAL ASSEMBLY ON THE  
ACCOUNTS OF THE VOLUNTARY FUNDS ADMINISTERED BY THE UNITED  
NATIONS HIGH COMMISSIONER FOR REFUGEES FOR THE YEAR ENDED  
31 DECEMBER 1962**

1. The United Nations High Commissioner for Refugees (UNHCR) submitted the following financial statement, together with associated schedules for audit certificates:

- I. Statement of assets and liabilities as at 31 December 1962;
- II. Statement of income, expenditure, surplus and balances for the year ended 31 December 1962;
- III. Schedule 1. Cash and investments as at 31 December 1962;
- IV. Schedule 2. Statement of loan operations;
- V. Schedule 3. Statement of income of current programme of UNHCR;
- VI. Schedule 4. Statement of income and expenditure of Emergency Fund;
- VII. Schedule 5. Statement of income—Relief operation in Algeria;
- VIII. Schedule 6. Statement of expenditure—transmission of earmarked contributions;
- IX. Schedule 7. Statement of income, expenditure and balances of restricted funds;
- X. Schedule 7a. Detailed statement of income, restricted funds;
- XI. Schedule 8. Detailed statement of income of funds for refugees from Algeria;

2. The administrative expenditure of UNHCR for 1962 was \$2,586,070.00. Against this, a sum of \$650,000.00 was paid to the United Nations in a global amount as a grant-in-aid of the administrative expenditure.

The amount of \$650,000.00 was paid out of the funds mentioned below to the extent noted against each:

The other funds were not charged with any part of the grant-in-aid.

3. The assets of all voluntary, restricted and trust funds as at 31 December 1962 totalled \$34,786,319.47. Liabilities totalled \$33,434,474.72. The assets thus exceeded the liabilities by \$1,351,844.75, a break-down being:

6. Reference is made to paragraph 6 of the last year's report.<sup>1</sup> There has been further improvement in accounting and in the follow-up on financial reporting and on audit observations. The Board has noted that efforts are continuing to effect further improvement.

7. Reference is made to paragraph 7 of the last year's report. The position has improved during 1962 and it has been possible for the Office of UNHCR to determine the amounts of the loans and the amounts of the grants separately to a considerable extent.

8. Reference is made to paragraph 8 of the last year's report regarding the stamp plan. The final accounts of the stamp plan were compiled by the UNHCR as at 31 July 1962. The statement of income and expenditure as at that date shows the following position:

According to the agreement between the Office of the UNHCR and the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), one quarter of the proceeds of the plan were to be used for Palestine refugees in the Middle East and the remaining three-quarters for the UNHCR's programmes. The shares of the UNHCR and the UNRWA work out to \$1,166,731.09 and \$388,910.36 respectively. The share of UNRWA has since been paid, and the share of UNHCR has been distributed, with the approval of the Executive Committee of UNHCR, as follows:

9. In respect of the projects in Greece, the UNHCR was able to obtain accounts relating to the sixteen projects which had been completed by 31 December 1960. As a result of the scrutiny of these accounts, the UNHCR has been able to obtain the acceptance of the Government of Greece for the refund of a sum of \$223,064.00 being the unutilized portion of the funds of UNHCR.
