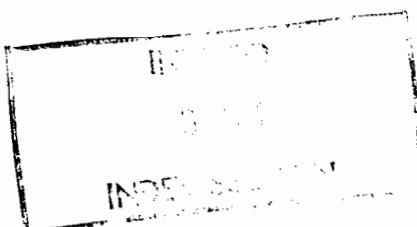

## FIRST ADDENDUM TO THE REPORT

### Observation of the presidential elections of the Republic of Korea

1. Pursuant to its mandate from the General Assembly, the United Nations Commission for the Unification and Rehabilitation of Korea (UNCURK) conducted a country-wide observation of the presidential elections of the Republic of Korea, held on 15 October 1963. It is most significant to note in this connexion that whereas preceding Administrations have indeed extended UNCURK ample co-operation and facilities in the observation of internal developments, including elections, the incumbent Administration is the first to take the initiative of inviting UNCURK for the observation of the National Referendum on the Constitution Amendments of December 1962, and the presidential and National Assembly elections of October and November of this year, respectively.

2. In the case of the presidential elections, the Commission organized nine observation teams which spent six days in eight of the nine Provinces and the Special Cities of Seoul and Pusan between 12 and 17 October 1963. The teams covered about 4,400 miles, conducting observations in twenty cities, fifty-one *guns* and *kus* and numerous *ups*, *myuns* and *ris*.<sup>1</sup> On 15 October—the election day itself—the teams observed balloting at 150 voting stations and attended ballot-counting at twenty-four vote-counting stations. The teams carried out the observation freely and without the imposition of any restrictions whatsoever.

3. Interviews were conducted with the provincial and local election management committees, representatives of political parties and editors of local newspapers. In addition, the teams availed themselves of the widest possible opportunity to interview numerous citizens of all walks of life. Whenever appropriate and necessary, interviews were held in private. Also, courtesy calls were made on provincial and local government officials.

4. Upon returning to Seoul, the nine observation teams reported orally on their individual findings to the Commission during its plenary meeting held on 18 October 1963. Subsequently, the individual teams concerned submitted their written reports which, along with their statements and deliberations thereon, form the basis of the present addendum.

5. In a press release dated 18 October, the Commission declared that the evaluation of its findings, as well as other matters falling within the terms of reference of UNCURK, would be covered in an addendum to the annual report which had been earlier submitted to the United Nations General Assembly at its eighteenth session.<sup>2</sup> The Commission further declared that it was in a position, at that stage, to state that on the basis of the observations of its nine teams, the voting had been "properly organized and held in an orderly and regular manner".

6. The result of UNCURK's observations of the recent presidential elections may be summarized as follows.

7. The Commission covered, as extensively as possible, the three phases of observation, namely the pre-election period, the election day and the post-election period. Its findings are based on each of these respective phases of observation.

8. During the course of the election observation, courtesy calls on government officials, interviews with Election Management Committee and Party officials and private persons enabled the teams to establish that enlightenment campaigns on voting procedures, party campaigning, as well as the combination of the voters' lists had in general been carried out properly. There were only a minimum number of complaints.

9. Criticism directed at the Government and the pro-Government Democratic Republic Party (DRP), even by officials of the opposition Minjong Dang (Civil Rule Party), was not as intense as might have been expected and mainly centred around the alleged "early" organization of the DRP with excessive funds which, they said, constituted a severe handicap to the opposition.<sup>3</sup>

10. It is appropriate to mention in this connexion that in most areas visited, only the DRP and the Minjong Dang maintained offices, indicating the acceptance of the fact that only these two parties were generally regarded as the main contestants of the elections.

11. During election day, the observation teams witnessed no flagrant or relevant irregularities in the voting and vote-counting processes. A few minor non-conformities in election proceedings were fundamentally attributed to untoward omission rather than premeditated commission. On the whole, procedures were carried out in a free atmosphere and in an orderly, calm and proper manner. The teams could notice no unauthorized persons anywhere, and the police, who were unarmed, were seldom encountered, except outside the limits legally prescribed for voting stations. Moreover, the physical set-up in and around these stations was in full accord with the law.

12. The observation teams were accorded a most cordial welcome everywhere. No voting station refused entry or set a time limit for the visit of the teams, nor were the latter detained for any appreciable length of time prior to their access to the voting stations. This attests to the degree of thoroughness with which the Central Election Management Committee instructed election officials at all levels regarding the invitation accorded to UNCURK teams to enter voting stations throughout the Republic of Korea.

The observation teams, moreover, were in general able to witness the procedures followed at the opening of the first voting station as well as the closure of the balloting at the last station visited. The teams agreed that proceedings at all stations visited were in general very proper and in accordance with the pertinent law. Party representatives interviewed at or around most voting stations generally attested to the fairness of the elections, at any rate in stations assigned to them. Complaints brought to the attention of the teams comprised allegations of a few incidents of double or ghost voting.

14. Similarly, as far as the Commission was able to observe, vote-counting was conducted in accordance with the relevant law.

15. During the post-election period the teams, prior to returning to Seoul, obtained from government and Election Management Committee officials virtually final returns for their assigned areas. Party officials and private persons in general attested or conceded to the equitable conduct of the elections, especially in so far as the balloting and vote-counting phases were concerned.

16. The final election returns showed that of the 12,985,015 registered voters, 11,036,175 (84.99%) participated in the elections. The difference between the

two major contestants constituted a slim margin, Mr. Park Chung Hee drawing 4,702,640 (42.61%) and Mr. Yoon Bo Sun obtaining 4,546,614 (41.19%) of the votes. The margin thus was 156,026 (1.42%).

## SECOND ADDENDUM TO THE REPORT

### Observation of the National Assembly elections

1. The United Nations Commission for the Unification and Rehabilitation of Korea (UNCURK) conducted a nation-wide observation of the National Assembly elections of the Republic of Korea. The observation was made in accordance with UNCURK's mandate from the United Nations General Assembly and upon an invitation received from the Government of the Republic of Korea and the Central Election Management Committee.

2. UNCURK this time formed eight observation teams which covered the two Special Cities of Seoul and Pusan and eight of the nine Provinces of the country between 24 and 28 November 1963. The teams travelled about 5,400 miles, conducting intensive observations in more than 50 cities, *guns* and *kus* and numerous *ups*, *myuns* and *ris*.<sup>4</sup> On 26 November, the election day, balloting was observed at 186 voting-stations, and ballot-counting at 39 vote-counting stations. The teams' movements were unrestricted and they followed their itineraries to their full satisfaction. As in all previous observations by UNCURK, these itineraries were not made known in advance.

3. Officials of election management committees at all levels and of contesting political parties and their candidates were interviewed at every opportunity, as were editors and staff of local newspapers. Moreover, governors, mayors and other officials of the Government were visited with a view to obtaining information on matters pertaining to elections. The teams also interviewed numerous citizens of various social and economic strata to obtain their views on the elections. Whenever necessary and appropriate, these interviews were held in private.

4. As much as possible the teams observed the pre-election period, the election day and the immediate post-election phase of the elections. In these observations, due attention was given to prevailing conditions and public opinion in both urban and rural areas. On election day, no irregularities of any significance were observed in the voting or vote-counting procedures, which were generally carried out in a calm, free and orderly atmosphere, and in accordance with provisions of the law.

5. The Commission will cover in its next annual report the general assessment of these elections, including a number of allegations on the part of both government and opposition parties on matters of voting and counting procedures that may be contested by them, together with their allegations of irregularities in the

pre-election period. The Government has declared that alleged irregularities will be duly investigated and those guilty severely punished.

6. The final election returns showed that of the 13,344,149 registered voters 9,622,183 (72.1%) participated in the elections.<sup>5</sup> Out of these 3,112,985 (33.5%) voted for the pro-Government Democratic Republican Party (DRP) enabling it to gain 110 seats in the next National Assembly, including the 22 seats won under the proportional representation system.<sup>6</sup> The Minjong Dang (Civil Rule Party) of former President Yoon Bo Sun has emerged with 1,870,976 votes (20.2%) according it 41 seats, including 14 seats under the proportional representation system. The Democratic Party (DP), the Party of the People (POP) and the Liberal Democratic Party (LDP) have mustered a total of 2,838,311 votes (30.5%) according them 24 seats, including 8 seats under the proportional representation system. The DP received 13 seats, the POP 2 seats and the LDP 9 seats.

7. In conclusion, and on the basis of its observation of the voting and counting, the Commission is of the opinion that the recent National Assembly elections were carried out in a peaceful, orderly and fair manner.
