## Organizational and other matters

Reports to be considered at the forty-eighth and forty-ninth sessions

1. **The Chairperson** said that the States parties whose periodic reports would be reviewed at the forty-eighth session of the Committee against Torture, which would be held from 7 May to 1 June 2012, and the country and alternate country rapporteurs for each report were: Albania: Mr. Grossman and Mr. Gaye; Armenia: Ms. Gaer and Mr. Wang Xuexian; Cuba: Mr. Mariño Menéndez and Ms. Sveaass; Czech Republic: Mr Grossman and Mr. Wang Xuexian; Canada: Mr. Bruni and Ms. Belmir; Greece: Ms. Sveaass and Ms. Belmir; Russian Federation: Ms. Gaer and Mr. Bruni; Mexico: Mr. Mariño Menéndez and Mr. Gaye. Syria had been asked to submit a special report by 9 March 2012 and its country and alternate country rapporteurs were Mr. Grossman and Ms. Belmir.

2. States parties for which lists of issues prior to reporting would be adopted at the forty-eighth session for reports due in 2013 were: Azerbaijan; Chile; Colombia; El Salvador; Honduras; Israel; Moldova; New Zealand; Slovakia; Spain; and the Philippines. Nicaragua had not yet accepted the new reporting procedure.

3. States parties whose reports would be reviewed at the forty-ninth session, which would be held from 29 October to 23 November 2012, were: Tajikistan; Togo; Senegal; Qatar; Rwanda; Norway; Peru; and Gabon.
