Annotations

1. Opening of the session

In accordance with past practice, the Under-Secretary-General for General Assembly and Conference Management will preside at the opening of the session and proceed with the nomination and election of the Chair.

2. Election of officers

Rule 103 of the rules of procedure of the General Assembly provides that committees other than Main Committees shall elect a Chair, one or more Vice-Chairs and a Rapporteur. These officers shall be elected on the basis of equitable geographical distribution, experience and personal competence. The Bureau of the Committee on Conferences comprises a Chair, three Vice-Chairs and a Rapporteur.

At its organizational session for 1989, held on 1 March 1989, the Committee agreed in principle that thenceforth the chairmanship would rotate annually among the regional groups. At its organizational session for 2011 (510th meeting), held on 20 April 2011, the Committee agreed in principle that the Chair would undertake informal consultations with a view to determining the composition of the Bureau for 2012 and that the Chair and the other members of the Bureau would continue in their capacities until the 2012 Bureau had been elected.

3. Adoption of the agenda and date for the organizational session for 2012

The Committee may wish to consider holding its organizational session on 25 April 2012 and taking up agenda item 4 (b) at that session.

4. Organization of work for 2012

At its organizational session for 2011, held on 20 April 2011, the Committee on Conferences adopted the agenda for its substantive session of 2011 and requested the Secretariat to submit to it at its organizational session for 2012 a provisional agenda for its substantive session of 2012.

(a) Intersessional departures and related matters

The Committee will consider requests for intersessional departures in accordance with paragraph 4 of General Assembly resolution 46/190 of 20 December 1991, in which the Assembly took note of the guidelines adopted by the Committee on Conferences (A/46/32, para. 77), and in accordance with the decisions taken by the Committee at its 373rd meeting, on 26 August 1994, at its 379th meeting, on 23 March 1995, and at its substantive session of 1995.

In accordance with legislative mandates, the Department for General Assembly and Conference Management will administer the programme of meetings as stated in the report of the Secretary-General on improving the performance of the Department (A/57/289, para. 15).

Moreover, meetings of the Committee on Conferences may be required in compliance with paragraph 6 of resolution 35/10 A of 3 November 1980, by which the General Assembly decided that all proposals affecting the schedule of conferences and meetings made at sessions of the Assembly shall be reviewed by the Committee when administrative implications are being considered under the requirements of rule 153 of the rules of procedure of the Assembly.

(b) Proposed strategic framework for the period 2014-2015

In accordance with regulation 4.8 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation, the Committee may wish to review the proposed strategic framework once issued and to transmit its recommendations, if any, to the Chair of the Committee for Programme and Coordination.

5. Programme of work for 2012

The terms of reference of the Committee are set forth in paragraph 4 of General Assembly resolution 43/222 B of 21 December 1988.

The annex to the present document contains a provisional agenda for the substantive session of 2012. The provisional agenda takes into account standing mandates from the Committee and the General Assembly, as well as information requested by the Assembly in its resolution 66/233 of 24 December 2011 on the pattern of conferences and under section 2, General Assembly and Economic and Social Council affairs and conference management, of its resolution 66/246 of 24 December 2011 on questions relating to the proposed programme budget for the biennium 2012-2013. In the annotations to the provisional agenda the relevant paragraphs in the above resolutions are referred to instead of being quoted in extenso.

The information requested by the General Assembly will be presented in a consolidated report of the Secretary-General on the pattern of conferences. Statistical and other relevant data will be presented as supplementary information to the report, as was done in 2011.
