Joint communiqué issued on 17 August 1989 by the member countries of the Permanent Mechanism for Consultation and Concerted Political Action concerning the results achieved at the summit meeting of Central American Presidents held at Tela on 7 August 1989

The member countries of the Permanent Mechanism for Consultation and Concerted Political Action (Group of Eight) express their satisfaction at the results achieved at the recent summit meeting of Central American Presidents held at Tela, Honduras, which are helping to consolidate the peace process begun in the agreements of Esquipulas II, Alajuela and Costa del Sol and are conducive to the establishment of a firm and lasting peace in the region.

In that connection, they urge all parties interested in bringing peace to Central America to continue their efforts for the implementation of each and every one of the commitments undertaken at Tela and to direct their actions towards supporting unreservedly the firm political will for reconciliation displayed at this summit by the Central American Presidents.
