Preparatory Committee for the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects New York, 19-23 March 2012

I. Introduction

1. At its sixty-sixth session, the General Assembly adopted resolution 66/47, by which it decided that, pursuant to resolution 65/64, the second conference to review progress made in the implementation of the Programme of Action would be held in New York from 27 August to 7 September 2012; and also decided that the preparatory committee for the review conference would be convened in New York from 19 to 23 March 2012. In addition, the Assembly invited States, at the second review conference, to review progress made in the implementation of the Programme of Action, and, subject to the agenda of the conference to be agreed by the preparatory committee, encouraged them to explore ways to strengthen its implementation, including consideration of the possibility of convening a further open-ended meeting of governmental experts.

II. Organizational matters

A. Opening and duration of the session and list of participants

- 2. The Preparatory Committee held its session at United Nations Headquarters from 19 to 23 March 2012. The session was opened by the High Representative for Disarmament Affairs, who also made a statement. During the session, the Preparatory Committee held a total of 10 formal meetings and __ informal meetings.
- 3. The Chief of the Disarmament and Peace Affairs Branch in the Department for General Assembly and Conference Management served as Secretary of the Preparatory Committee.

Recommendation II Other officers of the Conference

The Preparatory Committee decides to recommend that the United Nations Conference to Review Progress Made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects re-elect 14 Vice-Chairs of the Preparatory Committee, comprising two representatives of the African States and three of each of the other regional groups, as its Vice-Presidents.

The rules of procedure as contained in document A/CONF.192/2006/RC/5 shall be amended accordingly.
