Extensions of ongoing country programmes

Note by the secretariat

Summary

In accordance with Executive Board decision 2009/11, this note informs the Executive Board of the one-year extensions approved by the Executive Director for the country programmes for Cuba, Mexico, Nigeria and Togo, as well as the Gulf Area subregional programme.

This note also presents the reasons for the proposed two-year extensions of the country programmes for Colombia and Comoros, the second one-year extensions for Tunisia and Madagascar and the third-year extension for Namibia. The Executive Board is requested to approve these programme extensions.

Draft decision

The Executive Board

- 1. *Takes note* of the one-year extensions approved by the Executive Director for the country programmes for Cuba, Mexico, Nigeria and Togo, as well as the Gulf Area subregional programme, as indicated in table 1.
- 2. Approves the two-year extensions for Colombia and Comoros, the second-year extension for Tunisia and Madagascar and the third-year extension for Namibia, as presented in table 2.
