Annex to the letter dated 10 May 2012 from the Permanent Representative of Turkey to the United Nations addressed to the Secretary-General

Upon instructions from my Government, I have the honour to refer to the letter dated 3 May 2012, addressed to you by the Greek Cypriot representative and circulated as a document of the Security Council (A/66/790-S/2012/294), which yet again contains habitual allegations of violations of “international air traffic regulations and the national airspace of the Republic of Cyprus”, and to bring to your kind attention the following.

In response to such pretentious allegations, I wish, once again, to reiterate that flights within the sovereign airspace of the Turkish Republic of Northern Cyprus take place with the full knowledge and consent of the appropriate authorities of the State, over which the Greek Cypriot administration in South Cyprus has no jurisdiction or right of say whatsoever. It must be stated that assertions of so-called violations of air traffic regulations are invalid, as the civil aviation authority of the Turkish Republic of Northern Cyprus is the only competent authority to provide air traffic and aeronautical information services.

As noted in our previous letters, such claims are based on the false and unlawful claim that the sovereignty of Greek Cypriot administration extends over the whole island, including the territory of the Turkish Republic of Northern Cyprus. This pretentious contention by the Greek Cypriot side ignores the present realities on the island of Cyprus, namely, the existence of two independent States, each exercising sovereignty and jurisdiction within its respective territory.

Continuous attempts by the Greek Cypriot side, through often repeated false claims, to confer legitimacy upon an illegal administration will be futile since the Turkish Cypriot people will never give in to their unjust demands. What would indeed be conducive to a better atmosphere on the island would be for the Greek Cypriot side to stop arrogating for itself the rights and responsibilities it does not legally have, and to cease its hostile and derogatory acts against the Turkish Cypriot people.

Moreover, the Greek Cypriot administration should be reminded that its counterpart is, and has always been, the Turkish Cypriot side, not Turkey, and that its insistent denial of the Turkish Cypriot rights in the North of the island does not bode well for the prospects of a lasting settlement of the Cyprus conflict in line with the established United Nations parameters, namely a partnership based on a bi-zonal, bi-communal federation with the political equality of the two Constituent States.

At a time when the future of the negotiation process is being discussed by the two sides, the Greek Cypriot side’s hostile stance against Turkey and the Turkish Cypriots and its use of every available outlet to repeat these fabricated accusations are further deteriorating what little is left of the trust between the two communities, which will be vital for the success of any future settlement.

It is unfortunate that the Turkish Cypriot side’s vision of establishing a bi-zonal, bi-communal federation based on political equality, with two Constituent States of equal status, is not shared by the Greek Cypriot side, which prefers to gain time in the hope of imposing the terms of a likely settlement in the future. Its failure to reciprocate our goodwill and determination to find a just and equitable settlement

to the Cyprus problem, and its unilateral, provocative actions in and around the island, are not signs of encouragement for all those whose efforts are geared towards the creation of conditions that would serve peace and stability in the region.

Nevertheless, I would like to put on record once again that, despite the Greek Cypriot leadership's apparent lack of enthusiasm for compromise and its denial of the equal partnership rights of the Turkish Cypriots on the island, the Turkish Cypriot side is ready and doing its best to achieve a settlement in the form of a new partnership that will be in line with the established United Nations parameters and body of work.
