Election of six members of the Economic and Social Council (*concluded*)

[Agenda item 14]

1. The PRESIDENT: The first item on the agenda is the continuation of the election of members of the Economic and Social Council. Representatives will recall that last Saturday morning [389th meeting] ten inconclusive ballots were cast, and there now still remains one seat on the Council to be filled. The tenth ballot was an unrestricted one under our rules of procedure, the previous balloting having been restricted. The present ballot, the eleventh, will therefore also be unrestricted. The representatives may, in this ballot, vote for any eligible candidate.

A vote was taken by secret ballot.

At the invitation of the President, Mr. Lescure (Argentina) and Mr. Thant (Burma) acted as tellers.

2. The PRESIDENT: As the necessary two-thirds majority has not been obtained, there will be a twelfth ballot which, under the rules, will also be unrestricted.

A vote was taken by secret ballot.

At the invitation of the President, Mr. Lescure (Argentina) and Mr. Thant (Burma) acted as tellers.

3. The PRESIDENT: A thirteenth ballot is required. Under our rules, the thirteenth ballot should be restricted to the two countries having the highest number of votes on the twelfth ballot. This ballot will therefore be restricted to Yugoslavia and Czechoslovakia.

Election of two members of the Trusteeship Council

4. The PRESIDENT: Two vacancies will occur in the membership of the Trusteeship Council at the end of this year, El Salvador and Iraq being the retiring members. In this election, all Members of the United Nations are eligible, including the two retiring Members, with the exception, of course, of the following ten members of the Trusteeship Council General Assembly-Seventh Session-Plenary Meetings

whose terms do not expire on 31 December of this year: Australia, Belgium, China, Dominican Republic, France, New Zealand, Thailand, the USSR, the United Kingdom and the United States. As in previous elections, no nominations may be made. We shall now proceed to vote by secret ballot for two members of the Trusteeship Council.

A vote was taken by secret ballot.

At the invitation of the President, Mr. Lescure (Argentina) and Mr. Barrington (Burma) acted as tellers.
