Extensions of country programmes Note of the Administrator

Summary

The present note contains information on the extensions of the country programmes for Bhutan, Colombia, Comoros, Cuba, Mexico, Namibia, Nigeria, Rwanda, Togo and Tunisia. Requests for first one-year extensions of country programmes are approved by the Administrator and presented to the Executive Board for information. The requests for second one-year extensions and two-year extensions of country programmes are submitted to the Executive Board for approval.

Elements of a decision

The Executive Board may wish to take note of the first one-year extensions of the country programmes for Bhutan, Cuba, Mexico, Nigeria and Togo for a period of one year, from 1 January to 31 December 2013, and Rwanda for a period of six months, from 1 January to 30 June 2013, as reported in Table 1.

The Executive Board may wish to approve the two-year extensions of the country programmes for Colombia and Comoros from 1 January 2013 to 31 December 2014, and the second one-year extensions of the country programmes for Namibia and Tunisia, from 1 January to 31 December 2013, as presented in Table 2.
