Identical letters dated 13 July 2012 from the Permanent Representative of the Syrian Arab Republic to the United Nations addressed to the Secretary-General and the President of the Security Council

Upon instructions from my Government, and following my letters dated 16-20 and 23-25 April, 7, 11, 14-16, 18, 21, 24, 29 and 31 May, 1, 4, 6, 7, 11, 19, 20, 25, 27 and 28 June and 2, 3, 9, 11 and 13 July 2012, I have the honour to transmit herewith a detailed list of violations of the plan for cessation of violence that were committed by armed groups in Syria on 10 July 2012 (see annex).

It would be highly appreciated if the present letter and its annex could be circulated as a document of the Security Council.

Tuesday, 10 July 2012

Governorate of Rif Dimashq

- 1. On 9 July 2012 at 2100, an armed terrorist group fired at a law enforcement patrol at the Dariya juncture, killing Sgt. Muhammad al-Sabti.
- 2. On 9 July 2012 at 2200, an armed terrorist group abducted Cpl. Hasan Sulayman at the Harasta housing project.
- 3. On 9 July 2012 at 2230 hours, an armed terrorist group abducted Sgt. Muhammad Habib in the area of Ra's al-Ma'arrah.
- 4. On 9 July 2012 at 2300, an armed terrorist group shot and killed civilian worker, Ammar Rizq, on the outskirts of Qudsayah.
- 5. On 9 July 2012 at 2300, an armed terrorist group fired at law enforcement personnel in the area of Dayr al-Asafir, wounding one of them.
- 6. On 9 July 2012 at 2300, an armed terrorist group fired at guard personnel between the Military Technical College and the Vehicle Administration gate, wounding one of them.
- 7. At 0245, an armed terrorist group attacked a military barracks and abducted seven men with their weapons.
- 8. At 0400, an armed terrorist group attacked the law enforcement point in Rif Dimashq, bound personnel, and stole five rifles.
- 9. At 0600, an armed terrorist group shot Conscript Mustafa Muhaymid on Nahr Ayshah Road, killing him.
- 10. At 0700, an armed terrorist group set up an ambush of a car transporting a number of officers on al-Damir Airport Road east of the French Cemetery and attempted to abduct the officers, resulting in the killing of Brig. Gen. Yusuf Ali, the theft of his weapon, and the wounding of two colonels.
- 11. At 0700, an armed terrorist group fired at a car transporting an officer and his sister on al-Damir Airport Road, east of the French Cemetery, killing the officer's sister, citizen Hawriyah Khaznah.
- 12. At 0800, an armed terrorist group detonated an explosive charge and fired at law enforcement personnel in the area of Dayr al-Asafir, killing Cpl. Muhsin Ibrahim and wounding a major and another element [other rank or enlisted man].
- 13. An armed terrorist group stole a Honda Civic vehicle, licence No. 571212/Damascus, belonging to the MTN Telecommunications Company on Sahnaya Road, near the Abd-al-Baqi gas station.

- 14. An armed terrorist group abducted citizen Bashar Abd-al-Qadir, born 1979 in Safita, on al-Dahadil Road.
- 15. An armed terrorist group in the village of Dariya stole a public Hyundai Verna vehicle, licence No. 472240/Damascus, from its driver, Rashad Bin Ghadir Hadi, near the Abd-al-Baqi gas station.
- 16. An armed terrorist group assaulted al-Thaminah School in Dariya, trashed it, and stole equipment, electronic devices, and other items.
- 17. An armed terrorist group in the area of Dariya abducted two citizens, Muhammad Idris Yusuf, born 1977, and Hasan Muhammad Fadil, born 1981. It stole their car, a Shanghai pickup, licence No. 772286/Damascus. The group demanded a ransom of LS 10 million from Muhammad Idris Yusuf's brother, citizen Ziyad.
- 18. An armed terrorist group in the village of Dariya stole a Mitsubishi Outlander car, licence No. 574659/Damascus, belonging to the Malaysian company Raniko Sarzwid [phonetic].
- 19. An armed terrorist group in the village of Dariya fired at citizen Feras Abu Suhaylah, born in 1977 and an employee in Dariya Financial Department, as he was driving his car. He was able to escape without harm.
- 20. An armed terrorist group stole a Government Volkswagen vehicle, licence No. 538371/Damascus, belonging to the Syrian Arab Airlines, from its driver, Muhammad Eid Yasin, in the locality of Hawsh Blas Bur Sa'id.
- 21. An armed terrorist group stole a Hyundai car, licence No. 962038/Damascus, belonging to the Dijlah Petroleum Corporation, from its driver, Nabih Jarjas Kharashin.
- 22. An armed terrorist group stole a Toyota microbus, licence No. 543254/ Damascus, belonging to the Public Electricity Authority in Rif Dimashq.
- 23. An armed terrorist group stole eight computers from al-Muhdathah Mixed School in Sahnaya.
- 24. An armed terrorist group stole a Kia Rio vehicle, licence No. 483729/Damascus.
- 25. An armed terrorist group stole a public Kia Rio vehicle, licence No. 444189/Damascus, from its driver, Muhammad Taysir Jabar.
- 26. An armed terrorist group stole a Suzuki Alto car, licence No. 317959/Damascus, while it was being driven by citizen Faysal Diyab. The group left the car with its keys inside it in Ashrafiyah Sahnaya.
- 27. The body of an unknown person was found in Judaydat al-Fadl, near the water unit.
- 28. Citizen Abd-al-Hamid al-Bushi Bin Ali, born 1951, was admitted to al-Fatih Hospital in the village of Kafr Batna, after being shot in the head when he assisted two unknown persons on whom armed terrorists had fired. He was later pronounced dead.
- 29. The bodies of two persons killed by gunfire at the locality of Hazzah were found. They belong to two citizens Ahmad Abd-al-Razzaq Hamid, 30, and volunteer Sgt. Ahmad Abd-al-Qadir al-Masri, a taxi driver born in 1970.

- 30. An unidentified body was found in the city of Hamuriyah, near the sewer.
- 31. An armed terrorist group in the city of Duma stole a privately owned microbus from the driver, Zuheir Kilawi, licence No. 770352/Rif Dimashq, belonging to al-Kilawi Brick Company.
- 32. An armed terrorist group in the city of al-Tall killed Chief Warrant Ofc. Ahmad Muhammad Yunus, born 1970 in Jablah, and his son, Nur, 16, in front of their home in the locality of Ma'arba.
- 33. An armed terrorist group stole a white Toyota ambulance belonging to al-Tall hospital, licence No. 899641/Rif Dimashq, when the ambulance was present to aid citizen Abd-al-Salam Bin Ahmad al-Muyassir, who died immediately after a traffic accident in Ma'arba.
- 34. In the village of Babila, an explosive charge placed under a Government Nissan Patrol car, licence No. 671362/Damascus, belonging to Electrical Power Transmission and Generation, exploded, killing the driver of the car, Ibrahim Khalil al-Khadr, born 1956.
- 35. An armed terrorist group in the locality of al-Sabinah, on al-Assali Road, stole a Government owned Mazda 626 car, licence No. 228434, belonging to the State Planning Authority, from its driver, Muhammad Hani Bin Adil Shahin, born 1968.
- 36. At 0750, an armed terrorist group in the locality of al-Dhiyabiyah assassinated Sgt. Imad Bin Yusuf Jardu, born 1989, and Sgt. Khidr Bin Rida Quraytim, born 1987.
- 37. An armed terrorist group assassinated Col. Baha'-al-Din Bin Jamal Sulayman, born in 1966 in Latakia, by shooting him as he was driving his Volvo, licence plate No. 524384/Damascus, in the locality of al-Dhiyabiyah, on Mazari' Road.
- 38. An armed terrorist group in the village of al-Hajar al-Aswad stole a Government Sham car, licence No. 662209/Damascus, belonging to the Public Bakeries Company, from its driver, citizen Muhammad Bin Abd-al-Aziz al-Fadli, born 1961, in front of his house.

Damascus governorate

39. At 1000, the body of a killed man was found in the orchards of Tishrin Quarter. An examination showed that it belongs to citizen Muhammad Ahmad al-Zayn from Idlib, age 45. The victim's neck and body showed signs of torture and of being beaten with an iron rod on the forehead.

Governorate of Dar'a

- 40. On 9 July 2012 at 2200, an armed terrorist group fired at order-keeping personnel in Hamidah al-Tahir [Park], the Electricity Company Stop, the Train Station, and al-Na'imah Bridge.
- 41. On 9 July 2012 at 2300, an armed terrorist group fired at order-keeping personnel in al-Abbasiyin Quarter, on Talhah Bin al-Zubayr Street.
- 42. On 9 July 2012, at 2400, an armed terrorist group stole the furniture and contents of the Rural Development Centre in the village of Mahajjah. The group also stole bus number 977639 and agricultural tractor number 976937.

- 43. At 0200, an armed terrorist group fired at the border guard personnel in the area of Tall Shihab.
- 44. At 0700, an armed terrorist group stole a truck loaded with gas cylinders in al-Jizah.
- 45. At 0700, an armed terrorist group fired at order-keeping personnel in the city of Dar'a, al-Sahari Camp, wounding one of them.
- 46. At 1330, an armed terrorist group attacked a food truck belonging to the Officers' Club in Dar'a, near Dar'a Dam, wounding an element.
- 47. At 1345, an armed terrorist group threw a hand grenade at the Police Department of al-Muhattah from buildings neighbouring the department, wounding two police officers.
- 48. At 1400, an armed terrorist group conducted an armed attack against members of the Consumer Agency in Dar'a and attempted to abduct them.
- 49. At 1430, an armed terrorist group blocked traffic on the public road near the Preserves Factory and searched cars to intimidate citizens and look for police officers and order-keeping personnel.

Governorate of Homs

- 50. On 9 July 2012 at 2000, an armed terrorist group fired rounds, RPGs, and mortars at order-keeping personnel in al-Qarabis Quarter, wounding three of them.
- 51. On 9 July 2012 at 2100, an armed terrorist group fired rounds RPGs, and mortars at order-keeping personnel on al-Qahirah Street, wounding one of them.
- 52. On 9 July 2012 at 2100, an armed terrorist group fired rounds and RPGs at order-keeping personnel in al-Khalidiyah Quarter.
- 53. On 9 July 2012 at 2300, an armed terrorist group fired at order-keeping roadblocks in Tallkalakh, wounding an element.
- 54. On 9 July 2012 at 2300, an armed terrorist group fired at order-keeping personnel in Bab al-Siba'.
- 55. On 9 July 2012 at 2330, an armed terrorist group fired a heat-seeking missile at an order-keeping vehicle in al-Sultaniyah, killing Sgt. Samir Na'amah.
- 56. At 0130 hours, an armed terrorist group fired at order-keeping personnel near Talbisah Bridge, at the Agricultural Association roadblock.
- 57. At 0200, an armed terrorist group detonated an explosive charge in a car for transporting food to order-keeping personnel near the National Hospital in al-Qusayr.
- 58. At 0500, an armed terrorist group fired at order-keeping personnel in Karm Shamsham, killing 3 of them and 4 citizens and wounding 21 personnel.
- 59. At 0600, an armed terrorist group fired rounds and RPGs at order-keeping personnel in al-Khalidiyah Quarter, killing first Lieut. Basil Ibrahim and wounding a captain.
- 60. At 0600, an armed terrorist group fired rounds, RPGs, and mortars at order-keeping personnel in al-Sultaniyah Quarter, killing one man and wounding another.

- 61. At 0700, an armed terrorist group fired at order-keeping personnel in Joorat al-Shayyah, wounding two elements.
- 62. At 0700, an armed terrorist group fired rounds and RPGs at two order-keeping roadblocks at Jisr al-Amanah and al-Mahattah in al-Qusayr, killing conscript Qasim Askar.
- 63. At 0700, an armed terrorist group fired rounds, RPGs, and mortars at order-keeping personnel in al-Qusur, killing private Ali Dawa and wounding eight elements.
- 64. At 0900, an armed terrorist group fired rounds and RPGs at order-keeping personnel in Bab al-Siba' and next to al-Qal'ah.
- 65. At 0930, a group of armed terrorists fired sniper fire at order-keeping personnel in al-Hamidiyah Quarter, wounding one element.
- 66. At 1000, an armed terrorist group fired intermittently at order-keeping personnel in Wadi al-Sayih Quarter and next to Habbus restaurant.
- 67. At 1100, an armed terrorist group fired rounds and RPGs at order-keeping personnel on al-Qahirah Street, wounding one man.
- 68. At 1645, an armed terrorist group fired an RPG at an order-keeping car near Bab Tadmur roundabout, wounding four elements, including a major and first lieutenant, and heavily damaging the car.

Governorate of Hamah

- 69. On 9 July 2012 at 2000, an armed terrorist group fired at citizen Muhammad al-Yusuf in the village of al-Fan al-Shamali, wounding him.
- 70. On 9 July 2012 at 2030, an armed terrorist group blocked the path of Government truck number 272804, which was transporting six order-keeping personnel. The group abducted the six men and took them to Idlib. The truck driver was able to escape.
- 71. On 9 July 2012 at 2100, an armed terrorist group abducted Lieut. Ahmad Ma'yuf and his wife and children as they travelled from Damascus to Kafr Zayta.
- 72. On 9 July 2012 at 2200, an armed terrorist group fired at an order-keeping roadblock near the School of Arts on al-Arba'in Street.
- 73. On 9 July 2012 at 2250, an armed terrorist group fired various weapons at an order-keeping roadblock in al-Arba'in Quarter from the side of al-Khayrat Mosque.
- 74. At 0130, an armed terrorist group fired at an order-keeping roadblock in the village of Qubbat al-Kurdi-Salmiyah.
- 75. At 0130, an armed terrorist group fired at order-keeping personnel near al-Masbah and near al-Sabuniyah roundabout.
- 76. At 0750, an armed terrorist group detonated an explosive charge and fired at an order-keeping patrol between the village of Ayu and the village of Kafr Buhum, killing Warrant Officer Ammar Dawa, Master Sgt. Mahmud Wassuf, Master Sgt. William Muhammad, and worker Asif Ali and wounding remaining members of the patrol.

- 77. At 1000, an armed terrorist group abducted university student John Sulayman between the villages of al-Jalmah and Tall Malah after pulling him out of a microbus.
- 78. At 1220, an armed terrorist group stole car number 336990 belonging to citizen Talal Minshar on al-Hamamiyaht-Kafr Zayta Road, locality of al-Sakhrah.
- 79. At 1240, an armed terrorist group planted an explosive charge near al-Hal Market.
- 80. At 1300, an armed terrorist group stole Government car number 942335 belonging to the Secretariat of the Governorate of Hamah in al-Manakh Quarter.
- 81. At 1300, an armed terrorist group threw a hand grenade at order-keeping personnel in Suran, wounding three of them.
- 82. At 1400, an armed terrorist group stole public taxi number 031879 from its owner, citizen Ala' Shaykh al-Zawr, when it was in front of the College of Dentistry in al-Shari'ah Quarter.
- 83. At 1430, an armed terrorist group fired at an order-keeping roadblock near Suran Bridge.

Governorate of Aleppo

- 84. On 9 July 2012 at 2000, an armed terrorist group abducted citizen Abd-al-Badi' Ahmad al-Hajj Jamal.
- 85. On 9 July 2012 at 2130, an armed terrorist group stole new and used spare parts from the depot belonging to the Tishrin Dam Establishment located in the District of Manbij-Khirbat Zammalah Village Road.
- 86. On 9 July 2012 at 2200, an armed terrorist group fired at citizen Mahmud al-Hazza' in Lawand cafeteria, killing him.
- 87. On 9 July 2012 at 2200, an armed terrorist group broke into the home of As'ad al-Rajab, abducting him and his brother, Muhammad al-Rajab.
- 88. On 9 July 2012 at 2250, an armed terrorist group detonated an explosive charge at the order-keeping roadblock in the locality of Bustan al-Qasr, wounding four personnel and four citizens.
- 89. At 0700, an armed terrorist group fired at citizen Ahmad Zinah when he was in front of his house in the locality of Bustan al-Basha, wounding him.
- 90. At 1000, an armed terrorist group attacked the Central Electricity Warehouse in the area of Khan al-Asal, stealing six Government cars and the guards' weapons.
- 91. At 1100, an armed terrorist group broke into the Tobacco Distribution Centre in the district of Afrin.
- 92. At 1600, an armed terrorist group planted an explosive charge in the locality of al-Salihin.
- 93. At 1630, an armed terrorist group threw a bomb at an overnight bus transporting personnel from the Air College on the Halab-al-Raqqah Road at al-Jabiriyah juncture.

Governorate of Idlib

- 94. At 0830, an armed terrorist group detonated an explosive charge in a border guard patrol on the Jisr al-Shughur-Darkush Road, killing Conscript Jamil al-Ahmad and wounding two patrol members.
- 95. At 1330, an armed terrorist group fired at a car carrying food belonging to the Order-Keeping Forces on Jisr al-Shughur Road, near the village of Marj al-Zuhur.
- 96. At 1400, an armed terrorist group fired at an order-keeping roadblock in Kansafrah, wounding two elements.

Governorate of Dayr al-Zawr

- 97. On 9 July 2012 at 2000, an armed terrorist group abducted Lieut. Qusay al-Ali in the village of al-Ludhachi.
- 98. On 9 July 2012 at 2100, an armed terrorist group fired at order-keeping personnel in Dayr al-Zawr, killing conscript Milad al-Ahmad and wounding three elements.
- 99. At 1830, an armed terrorist group set up an armed ambush against an order-keeping patrol in al-Bukamal, al-Baghuz locality, killing Staff Sgt. Hamid Khalil, Cpl. Tariq Muhammad, Cpl. Abd-al-Karim Anjah, Cpl. Issa Mutillah, and Cpl. Mahmud Fayyad, and wounding five elements.

Governorate of Hasakah

- 100. On 9 July 2012 at 2000, an armed terrorist group attacked the Pastoral Nursery on al-Hasakah-Dayr al-Zawr Public Road, tied up the guard, and stole his weapon.
- 101. On 9 July 2012 at 2100, an armed terrorist group attacked the agricultural extension unit in the village of al-Arba'in-Ra's al-Ayn, wounding the head of the extension unit.

Governorate of al-Raqqah

102. At 7.45 an armed terrorist group blocked the path of a bus belonging to Al-Eman Co. on his way from Aleppo to Damascus and abducted 6 elements after forcing them out at gun point.

Syrian-Lebanese border

103. On 9 July 2012 at 2200, an armed terrorist group fired from Lebanese territory at border guard personnel in the district of Talkalakh, and secretariat of immigration at Jisr Qammar, wounding two border guard members.

Syrian-Turkish border

104. At 1100, an armed terrorist group attempted to infiltrate from Turkish territory into Syrian territory and fired at border guard personnel in the area of Khirbat al-Jawz, Abu Hani locality.
