Upon instructions from my Government, and following my letters dated 16-20 and 23-25 April, 7, 11, 14-16, 18, 21, 24, 29 and 31 May, 1, 4, 6, 7, 11, 19, 20, 25, 27 and 28 June and 2, 3, 9, 11 and 13 July 2012, I have the honour to transmit herewith a detailed list of violations of the plan for cessation of violence that were committed by armed groups in Syria on 12 July 2012 (see annex).

It would be highly appreciated if the present letter and its annex could be circulated as a document of the Security Council.

Thursday, 12 July 2012

Governorate of Rif Dimashq

- 1. On 11 July 2012 at 2000 hours, an armed terrorist group abducted a worker, Sulayman Darwish, with his Land Rover vehicle, in al-Sabil quarter of Harasta.
- 2. On 11 July 2012 at 2200 hours, an armed terrorist group fired at law enforcement forces roadblocks in Assal al-Ward, killing Conscript Basil al-Hamdu and wounding another man.
- 3. On 11 July 2012 at 2200 hours, an armed terrorist group shot and killed Sergeant Khidr Quraytim in front of his house in the area of al-Sayyidah Zaynab-al-Dhiyabiyah.
- 4. At 0200 hours, an armed terrorist group attacked a law enforcement forces roadblock in Artuz at the Kawkab intersection and booby-trapped Artuz bridge with a large quantity of explosives, resulting in the wounding of three elements.
- 5. At 1200 hours, an armed terrorist group fired at law enforcement forces personnel in Zamalka, killing Chief Warrant Officer Muhammad Sulayman, Master Sergeant Ali Sharifah and Sergeant Amir Haddal. They also stole two rifles and a pistol.
- 6. At 1330 hours, an armed terrorist group shot and killed Sergeant Muhammad Habib after abducting him in Yabrud.
- 7. At 1400 hours, an armed terrorist group blocked the path of a car carrying law enforcement forces personnel in the area of al-Ash'ari. The group fired at the car, killing two persons and wounding another.
- 8. At 1530 hours, an armed terrorist group attacked a military barracks near the area of al-Sayyidah Zaynab.
- 9. At 1700 hours, law enforcement forces challenged armed terrorists who fired shots in the city of Dariya. The terrorists killed citizen Muhammad Ihsan Bin Muhammad Khayr al-Bani, born 1956 (a journalist with al-Thawrah newspaper) as he was passing by the location.
- 10. In the town of Hazrama in Duma district, an armed terrorist group abducted citizen Khalid al-Abid with a Nissan vehicle, licence No. 734895/Damascus. He was released two hours later.
- 11. In the city of Duma, an armed terrorist group stole two pickup vehicles belonging to the Awad Amurah Company. The two vehicles were transporting automotive oil. The first pickup bore licence plate No. 254001/Rif Dimashq. Its driver was Sulayman al-Shaykh Ahmad Darwish. The second pickup bore licence No. 681658/Rif Dimashq. Its driver was Mahmud Mahmud Mashhad Bin Hasan.

- 12. An armed terrorist group broke into al-Shayfuniyah municipal building and stole a car from the municipality bearing licence plate No. 930469/Rif Dimashq and some office contents.
- 13. An armed terrorist group abducted the head of the municipality of al-Darkhabiyah in the subdistrict of al-Kiswah, citizen Ayman Awad al-Najjar (born 1968), from his office and stole a GMC car belonging to the municipality, licence plate No. 530025/Rif Dimashq. The car was found in the locality of Darwasha.
- 14. In the city of Dariya, an armed terrorist group stole a Toyota double-cabin vehicle, licence plate No. 171/11HD, belonging to the Canadian Embassy in Damascus from its driver Ra'fat Hussam-al-Din Baghdadi, born 1958 in Shughur.
- 15. In the city of Dariya, an armed terrorist group stole a Kia pickup, licence No. 621156/Dar'a, from its driver, Ahmad Sulayman Hammadah, born 1978.
- 16. The bodies of four unidentified persons killed by gunfire were found in the city of Harasta, west of the highway.
- 17. An armed terrorist group abducted citizen Hasan Ibrahim Azzar (born 1953) in the locality of al-Hajar al-Aswad, where the victim worked as a vegetable vendor.
- 18. Near the church in the city of Harasta, an armed terrorist group stole a Chevrolet pickup, licence plate No. 990189/Damascus, from its driver, Ali Bin Muhammad Husayn.
- 19. An armed terrorist group impersonating security personnel stole 20 million Syrian pounds from employees of the Syrian Commercial Services Company Ltd. as they travelled on al-Salam Highway.
- 20. Law-enforcement forces challenged terrorists in the orchards of al-Halalah and al-Barakah neighbourhood in the city of Qatna.
- 21. In the town of Judaydat Artuz, an armed terrorist group detonated an explosive charge near the town of Artuz, causing only material damage.
- 22. An armed terrorist group attacked law-enforcement forces roadblocks and the military police in the town of Judaydat Artuz.
- 23. An armed terrorist group detonated an explosive charge near the Qatna-Judaydat Artuz bridge. The group wounded one member of the law enforcement forces and a member of the military police guard with sniper rounds, and caused material damage to buildings and machinery located at the site.
- 24. A child, Haydar Abd-al-Jabbar al-Hamdan, born in 2000 in Idlib, was taken to al-Kamal Hospital in the town of Judaydat Artuz to be treated for a shrapnel wound in his right thigh.
- 25. The body of an unidentified person was found in a water ditch in Artuz Farms.
- 26. A terrorist named Majid Mawsilili from Zamalka fired at persons in front of al-Jabali Household Gas Distribution Centre, wounding Abu Mahrus al-Zaybaq and an unidentified person.
- 27. An armed terrorist group, using a Kia Forte car, licence plate unknown, attempted to abduct police officer Basil Kazim, of the traffic police station of Yabrud, as he was going to purchase several necessities in Yabrud. However, he was able to escape on a motorcycle.

- 28. The body of an unidentified person in his forties was found killed by a gunshot wound to the head in Wadi Barada at the locality of Ayn Tarma.
- 29. In Kafr Batna, an armed terrorist group stole a closed Government pickup truck, licence plate No. 200232/Damascus, belonging to the governorate of Damascus, Parks Department, from its driver, Muhammad Izz-al-Din al-Dabsh.
- 30. In the area of Dariya, the bodies of two unidentified persons in their fifties were found on al-Ma'amil Road, killed by gunshot wounds to the head and chest. The two bodies were transported to Dariya National Hospital.
- 31. The bodies of two unidentified persons in their forties and fifties were found on Shab'a-al-Malihah Road. The two persons had been killed by gunshots to the head. There were transported to Jarmana Hospital.
- 32. An armed terrorist group attacked the Public Roads Centre in al-Nabak from the direction of the highway. An exchange of fire occurred between centre personnel and the armed men. The terrorist group was countered with the assistance of law enforcement forces. The armed men escaped. A tow truck, licence plate No. 41027/Police, and an Opel, licence plate No. 39908, were damaged. The base of a memorial was damaged by a rocket-propelled grenade, and the building was hit.
- 33. An armed terrorist group abducted citizen Ali Bin Mustafa Fa'ur and Hamidah (born 1988 in Idlib, al-Faw'ah) from his handicraft store, located in Babila, next to the Agraba roundabout.
- 34. An armed terrorist group placed an explosive charge on a dark blue Volkswagen, licence plate No. 552306/Damascus belonging to the Religious Endowments Directorate of Damascus. The charge was disarmed by military engineering personnel.
- 35. The bodies of two persons killed by gunfire were found at the locality of al-Sayyidah Zaynab, Hujayrah, Ali al-Wahsh Street. One belonged to citizen Fadi Bin Ibrahim Ahmad, mother Miriam, born 1978 in al-Qunaytirah. He was abducted on 11 July 2012 from his grocery store in al-Hajar al-Aswad by a group of armed men using a Toyota Camry vehicle. The other body belonged to citizen Hasan Ibrahim Azzar, born 1953 in Idlib-al-Faw'ah, who was abducted on 11 July 2012. A piece of paper bearing the words "Free Army Battalions" was found near the two bodies.

Governorate of Damascus

36. At 1530, an armed terrorist group fired at a Suzuki pickup, licence No. 260853/Damascus, carrying 15 gas cylinders, near the Pullman tunnel, resulting in the death of two citizens, Muhammad Ma'ruf Bin Ali, born 1960, and Muhammad al-Shuwayki Bin Mustafa, born 1980. The two were on board the pickup. A soldier, conscript Ahmad Fayyad, who was at the site, was wounded and taken to the Ibn al-Nafis Hospital.

Governorate of Dar'a

37. On 11 July 2012 at 2000 hours, an armed terrorist group fired at Sergeant Hasan al-Abdallah , wounding him, and at citizen Usama Abu-Zayd in Dar'a, killing him.

- 38. On 11 July 2012 at 2100 hours, an armed terrorist group stole a car, licence No. 344837, belonging to citizen Hamdi al-Awdah in the village of Khirbat Qays.
- 39. On 11 July 2012 at 2200 hours, an armed terrorist group stole a Government car belonging to the First Dar'a Bakery, licence No. 976231.
- 40. On 11 July 2012 at 2300 hours, an armed terrorist group abducted citizen Muhammad al-Zu'bi in al-Tayyibah.
- 41. At 0700 hours, an armed terrorist group stole bus No. 977639 belonging to the Rural Development Centre at Mahajjah.
- 42. At 0800 hours, an armed terrorist group shot at the law enforcement forces roadblock at the entrance to the village of Sayda.
- 43. At 1000 hours, an armed terrorist group detonated a bomb in the city of al-Harrak to intimidate citizens.
- 44. At 1100 hours, an armed terrorist group abducted Conscript Bassam al-Muflih as he was riding in a public taxi in the city of Dar'a.
- 45. At 1130 hours, an armed terrorist group fired at personnel guarding the military barracks at al-Tayhah. The group fled, firing at citizens randomly, wounding a citizen and a girl child.
- 46. At 1200 hours, an armed terrorist group abducted police officer Sumar Khalil in the village of al-Surah as he was transporting mail from al-Harrak to Azra'.
- 47. At 1230 hours, an armed terrorist group hijacked a car, licence plate No. 396666, containing two members of the law enforcement forces, near al-Barid roundabout laundry.
- 48. At 1300 hours, an armed terrorist group fired at law enforcement forces roadblocks in al-Harah.
- 49. At 1500 hours, an armed terrorist group targeted and disabled the electric transformer in the town of al-Harah.
- 50. At 1900 hours, an armed terrorist group fired at law enforcement forces personnel at the Electricity Company Stop, al-Na'imah Bridge, Umm al-Mayadin Bridge, and Hamidah al-Tahir Park.

Governorate of Homs

- 51. On 11 July 2012 at 2000 hours, an armed terrorist group opened fire on citizen Fadi al-Ali near the Talbisah intersection, wounding a citizen.
- 52. On 11 July 2012 at 2100 hours, an armed terrorist group fired at law enforcement forces personnel in al-Qarabis, killing Conscript Ibrahim Junaydi.
- 53. At 0600 hours, an armed terrorist group fired rounds, rocket-propelled grenades and a mortar at law enforcement forces personnel in Bab al-Siba', al-Rastan, and al-Sayyid al-Ra'is roundabout.
- 54. At 0700 hours, an armed terrorist group fired rounds and rocket-propelled grenades at law enforcement forces personnel in Jawrat al-Shiyah, killing 3 and wounding 14 of them.

- 55. At 0800 hours, an armed terrorist group fired rounds and rocket-propelled grenades at law enforcement forces personnel in al-Qusur quarter and al-Qarabis, killing Corporal Tha'ir al-Ali, Corporal Muhammad Khalifah, Private Sa'd Lulu, and Conscript Sari Hallas, and wounding 12 others.
- 56. At 0800 hours, an armed terrorist group fired rounds and rocket-propelled grenades at law enforcement forces personnel in al-Sultaniyah, wounding three of them.
- 57. At 1000 hours, an armed terrorist group fired at law enforcement forces personnel in Talbisah, wounding one of them.
- 58. At 1255 hours, an armed terrorist group fired at vehicles travelling on the road connecting al-Hawash and al-Nasirah.
- 59. At 1600 hours, an armed terrorist group fired machine guns and Dushka machineguns at a car transporting food to law enforcement forces personnel on the Agricultural Nursery Road in al-Qusayr, wounding two men.
- 60. At 1800 hours, an armed terrorist group fired rounds and rocket-propelled grenades at law enforcement forces personnel in al-Qarabis, al-Qahirah Street, Karm Shamsham, Bab al-Siba', al-Khalidiyah quarter, al-Sultaniyah, al-Rastan, al-Qusayr, and the village of al-Husn.
- 61. At 1830 hours, an armed terrorist group blocked the path of law enforcement forces vehicle No. 902478 in Hasya', which belongs to Order-Keeping Forces.

Governorate of Hamah

- 62. On 11 July 2012 at 2000 hours, an armed terrorist group abducted citizen Khidr al-Sha'ar on al-Thawrah Street in the city of al-Salmiyah.
- 63. At 1030 hours, an armed terrorist group forced citizens to evacuate their homes in the village of al-Jalmah, Muhradah subdistrict.
- 64. At 1200 hours, an armed terrorist group shot and killed citizen Mu'ayyin Abbas as he was on his way to his parents' home in al-Safsafiyah.
- 65. At 1200 hours, an armed terrorist group attacked a law enforcement forces roadblock on al-Suqaylibiyah-Muhradah Road, at the site of the village of al-Jalmah, killing Master Sergeant Ahmad Ahmi and wounding a captain.
- 66. At 1430 hours, an armed terrorist group stole a truck, licence plate No. 939520, near Qitaz Mosque in the suburb of Abu al-Fida'.
- 67. At 1600 hours, an armed terrorist group attacked homes in the village of al-Tuwayni and al-Ghab, set fire to a number of nearby houses, abducted citizen Husayn al-Omar, and killed him by hanging him.
- 68. At 1800 hours, an armed terrorist group set up an armed ambush against a law enforcement forces patrol west of the village of Ma'an in the subdistrict of Suran.
- 69. At 1940 hours, an armed terrorist group shot citizen Ahmad Sulayman in Suran in an attempt to abduct him, wounding another citizen.

Governorate of Aleppo

- 70. On 11 July 2012 at 2000 hours, an armed terrorist group blocked the path of the car of physician Abdu Najjar, who was accompanied by his wife and children, as they travelled on the Damascus-Aleppo Public Road at al-Amiriyah juncture.
- 71. On 11 July 2012 at 2100 hours, an armed terrorist group shot and wounded citizen Rawwad al-Salih in the city of A'zaz.
- 72. On 11 July 2012 at 2130 hours, an armed terrorist group fired at law enforcement forces roadblocks in the locality of Salah-al-Din, wounding two men.
- 73. On 11 July 2012 at 2200 hours, an armed terrorist group fired at the home of the police commander in the locality of al-Shahba'.
- 74. On 11 July 2012 at 2300 hours, an armed terrorist group detonated an explosive charge at al-Sakhur roundabout, wounding a citizen and her daughter.
- 75. On 11 July 2012 at 2400 hours, an armed terrorist group booby-trapped a briefcase with an explosive charge and placed it in the locality of al-Aziziyah.
- 76. At 0130 hours, an armed terrorist group attempted to attack Kashish Airport. The group fired at two guards as it attempted to steal their weapons, wounding them and stealing a rifle.
- 77. At 0215 hours, an armed terrorist group fired at the Fodder Centre building in Dayr al-Hafir.
- 78. At 0230 hours, an armed terrorist group stole the car of citizen Ibrahim al-Mustafa in front of his home on Jarabulus Road.
- 79. At 0300 hours, an armed terrorist group placed an explosive charge near the residences of officers' families in the locality of Hannanu.
- 80. At 0730 hours, an armed terrorist group placed an explosive charge and a sound charge in the car of Colonel Ziyad al-Rabadawi and detonated the sound charge. The other charge was not detonated.
- 81. At 0800 hours, an armed terrorist group set up an armed roadblock at the intersection leading to the Air College, 5 km from the college, and abducted four officers and two men.
- 82. At 0830 hours, an armed terrorist group abducted citizen Fayiz Hajj Sulayman on the Halab-Jazraya Road in the village of Tall Bajir.
- 83. At 0900 hours, an armed terrorist group abducted citizen Ismail Khalalu, the head of the municipality of al-Atshanah, Maskanah subdistrict, Manbij district. The abduction occurred in the village of Abu Hanaya, al-Khafsah subdistrict.
- 84. At 0900 hours, an armed terrorist group fired at police patrols in the locality of al-Sulaymaniyah, killing Lieutenant Colonel Yassir Ismail Hajj Najib and wounding another police officer.
- 85. At 1100 hours, an armed terrorist group attacked the al-Mawalih Dam project in the village of al-Buwaydir, Tall al-Daman subdistrict.
- 86. At 1200 hours, an armed terrorist group booby-trapped a Peugeot car with a wireless explosive charge in the locality of al-Ashrafiyah.

- 87. At 1300 hours, an armed terrorist group fired at a law enforcement forces patrol and detonated a number of explosive charges in the locality of al-Sukkari, wounding four elements.
- 88. At 1330 hours, an armed terrorist group shot and killed citizen Hasan al-Ali in the locality of al-Sukkari.
- 89. At 1400 hours, an armed terrorist group shot and killed citizen Kannan Saryu in the locality of al-Ansari.
- 90. At 1400 hours, an armed terrorist group fired a heat-seeking missile at a vehicle of law enforcement forces in A'zaz. One member the forces sustained burns on his body.
- 91. At 1545 hours, an armed terrorist group shot and killed citizen Muhammad Zafir al-Yusuf in the locality of al-Ard al-Hamra.
- 92. At 1550 hours, an armed terrorist group detonated a sound bomb in front of the liquor store of citizen Jamil al-Zaqut in the locality of al-Haydariyah.
- 93. At 1600 hours, an armed terrorist group abducted citizen Hussam Abdallah at the intersection of the village of Arradah on the Aleppo-Damascus Road.
- 94. At 1700 hours, an armed terrorist group detonated explosive charges in Qabtan al-Jabal, killing citizen Sallum al-Husayn Taqqal and citizen Ahmad Ashur.
- 95. At 1800 hours, an armed terrorist group fired at law enforcement forces personnel in A'zaz, killing Lieutenant Colonel Dargham Yunus and Conscript Hasan Mahmud.
- 96. At 1800 hours, an armed terrorist group detonated a number of explosive charges in the subdistrict of Darah Izzah, killing citizen Awad al-Hallaq.
- 97. At 1900 hours, an armed terrorist group stabbed police officer Ala' al-Awwad with a screwdriver and pulled the trigger on his rifle during a struggle, which resulted in the wounding of two men.

Governorate of Idlib

- 98. On 11 July 2012 at 2030 hours, an armed terrorist group abducted and slaughtered 17 military personnel, throwing their bodies between the areas of Khan Shaykhun and Ma'arrat al-Nu`man.
- 99. At 1300 hours, between the villages of Hawa and Tall Amarah in Sinjar subdistrict, an armed terrorist group stole a car, licence plate No. 038678, belonging to citizen Abd-al-Salam al-Misri.
- 100. At 1300 hours, an armed terrorist group fired at law enforcement forces personnel on the Jisr al-Shughur-Ariha Highway, at the intersection of Kafr Najd, wounding one of them.
- 101. At 1400 hours, an armed terrorist group placed three explosive charges on the Jisr al-Shughur-Ariha Road, at the intersection of Basnaqul.
- 102. At 1530 hours, an armed terrorist group fired at law enforcement forces personnel in Khan al-Jawz-al-Qasatil, killing Sergeant Ra'id Hallaq and wounding a first lieutenant and a man.

Governorate of Dayr-al-Zawr

- 103. On 11 July 2012 at 2000 hours, an armed terrorist group fired at law enforcement forces personnel near al-Suyuf roundabout, killing Master Sergeant Husayn al-Ali and Conscript Muhammad al-Ma'arri and wounding five men.
- 104. On 11 July 2012 at 2200 hours, an armed terrorist group fired at law enforcement forces personnel on al-Takaya Street in Dayr al-Zawr, wounding a lieutenant.
- 105. At 1030 hours, in Dayr al-Zawr, an armed terrorist group abducted three law enforcement forces personnel, the car in which they were riding, and its civilian driver.
- 106. At 1330 hours, an armed terrorist group fired at law enforcement forces personnel near Ghassan Abbud roundabout, wounding a first lieutenant.

Governorate of Hasakah

107. At 0700 hours, an armed terrorist group blocked the path of a microbus carrying workers in the area of al-Shaddadah. The group stole a microbus and fired on another microbus because it did not stop. They stole the microbus after removing its driver from it.

Governorate of al-Raggah

108. At 1510 hours, an armed terrorist group detonated three explosive charges on a bus belonging to al-Thawrah Airport on al-Karin Road, wounding the driver and a lieutenant colonel and damaging the bus.

Governorate of Ladhiqiyah

- 109. On 11 July 2012 at 2200 hours, an armed terrorist group fired at law enforcement forces personnel in al-Haffah, killing Conscript Yusuf al-Hajji and wounding 15 men, including a lieutenant colonel.
- 110. At 0530 hours, an armed terrorist group fired at a law enforcement forces patrol on the Aleppo-Ladhiqiyah Road, at the site of Kafriyah-Saqiyat al-Kurd-al-Qasatil, wounding three men.

Syrian-Lebanese border

111. On 11 July 2012 at 2200 hours, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory. The group fired on a border guard in the border villages of Uyun al-Sha'rah and Halat.
