Emerging issues: future issues, i.e., nominations

Nomination of emerging policy issues for consideration by the International Conference on Chemicals Management at its third session

Note by the secretariat

- 1. One of the functions of the International Conference on Chemicals Management, as set out in paragraph 24 (j) of the Overarching Policy Strategy of the Strategic Approach to International Chemicals Management, is "to focus attention and call for appropriate action on emerging policy issues as they arise and to forge consensus on priorities for cooperative action". Paragraphs 14 (g) and 15 (g) of the Overarching Policy Strategy call, respectively, for existing, new and emerging issues of global concern to be sufficiently addressed by means of appropriate mechanisms, and for an acceleration of the pace of scientific research on identifying and assessing the effects of chemicals on human beings and the environment, including emerging issues.
- 2. At the second session of the International Conference on Chemicals Management, held in Geneva from 11 to 15 May 2009, representatives considered the modalities for carrying out the Conference's functions with regard to emerging policy issues. The annex to resolution II/4 sets out the procedures to be followed by the secretariat of the Strategic Approach to International Chemicals Management in receiving nominations for emerging policy issues and preparing them for future consideration.
- 3. An emerging policy issue is considered by the Conference to be an issue involving any phase in the life cycle of chemicals and that has not yet been generally recognized, is insufficiently addressed or arises from the current level of scientific information and which may have significant adverse effects on human health or the environment.
- 4. In accordance with the procedures adopted by the Conference at its second session, stakeholders wishing to nominate emerging issues for consideration at the Conference's third session, in 2012, should complete the questionnaire found in the annex to the present note and return it to the secretariat (by fax to 41 22 797 3460, or by e-mail to saicm@unep.org) by 30 November 2010.
- 5. An overview of the steps for the consideration of emerging policy issues by the Conference based on resolution II/4 is also contained in the annex to the present note.

Steps for considering emerging policy issues by the International Conference on Chemicals Management*

An emerging policy issue involves any phase in the life cycle of a chemical and that has not yet been generally recognized, is insufficiently addressed or arises from the current level of scientific information and which may have significant adverse effects on human health or the environment.

A. Call for nominations

Note: Deadline 18 months in advance of the next session of the Conference.

B. Submission of initial information

- (a) Why the issue is considered to be an emerging policy issue;
- (b) How the issue meets the selection criteria:
 - Magnitude of the problem and its impact on human health or the environment, taking into account vulnerable subpopulations and any toxicological and exposure data gaps;
 - (ii) Extent to which the issue is being addressed by other bodies, particularly at the international level, and how it is related to, complements or does not duplicate such work;
 - (iii) Existing knowledge and perceived gaps in understanding about the issue;
 - (iv) Extent to which the issue is of a cross-cutting nature;
 - (v) Information on the anticipated deliverables from action on the issue.

C. Initial review and publication of submissions

- (a) Secretariat to check nominations against agreed criteria. Proponents will be contacted to provide any missing information:
- (b) Secretariat to compile a list of nominations, annotated with summary information on each of the criteria, similar nominations to be grouped;
- (c) Secretariat to publish nominations and invite comment 15 months ahead of the Conference;
- (d) Proponents may submit revised nomination (within 3 months i.e., up to 12 months ahead of the Conference) and may join with other proponents;
- (e) Secretariat will consolidate a final list of nominations, annotated with a summary of information on each of the criteria.

D. Prioritization of submissions

- (a) Regions may prioritize the issues by engaging with Strategic Approach stakeholders including via regional and national focal points will be engaged in this process;
- (b) Secretariat to compile submissions on the priority of issues.
