Monday, 17 September 2012

1083rd and 1084th plenary meetings

Opening of the session

The fifty-ninth session of the Board was opened by H.E. Mr. Mothae Maruping (Lesotho), President of the Board, at its fifty-eighth session.

The President of UNCTAD XIII, H.E. Mr. Hamad bin Abdulaziz Al-Kawari, Minister of Culture, Arts and Heritage of Qatar, gave a special address.

Item 1 Procedural matters

(a) Election of officers

The Board elected by acclamation H.E. Mr. Jüri Seilenthal (Estonia) and H.E. Mr. Mukhtar Tileuberdi (Kazakhstan) as the joint Presidents of the Board at its fifty-ninth session.

The Board elected Mr. Kazem Asayesh (Islamic Republic of Iran) as its Rapporteur.

Following established practice, the Board agreed that the regional coordinators and other recognized groups of UNCTAD would be fully associated with the work of the Bureau.

(b) Adoption of the agenda and organization of the work of the session

The Board adopted its provisional agenda as contained in document TD/B/59/1/Rev.2. A detailed programme was made available to all delegations.

General statements

Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, addressed the Board.

Representatives of the following member States made statements: Indonesia (on behalf of the Group of 77 and China); Iran (on behalf of the Asian Group); Nigeria (on behalf of the African Group); Paraguay (on behalf of the Group of Latin American and Caribbean States); the European Union; Hungary (on behalf of Group D); Nepal (on behalf of the least developed countries); China; Paraguay (on behalf of the landlocked developing countries) and Sri Lanka (on behalf of the Group of 15).

Item 3 High-level segment: Growth with jobs for poverty reduction: What can Africa learn from other regions?

The high-level segment began its consideration of item 3 with presentations by the following panellists: Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD; H.E. Mr. Mothetojoa, Deputy Prime Minister, Kingdom of Lesotho; H.E. Mr. Robert Sichinga, Minister Commerce, Trade and Industry, Zambia.

This was followed by an interactive debate with statements by Mr. Heiner Flassbeck, Director of the Division on Globalization and Development Strategies; Mr. Taffere Tesfachew, Director of the Division for Africa, Least Developed Countries and Special Programmes; H.E. Mr. Jüri Seilenthal, President of the Board; Nepal, South Africa and Egypt.
