2. Adoption of the agenda and other organizational matters

The Economic and Social Council, in its decision 2011/259, entitled "Joint meetings of the reconvened sessions of the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice", decided that, starting in 2011, the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice should hold joint meetings during their reconvened sessions for the purpose of considering agenda items included in the operational segment of the agendas of both Commissions, with a view to providing integrated policy directives to the United Nations Office on Drugs and Crime on administrative, budgetary and strategic management issues. The Council also decided that the practice of holding back-to-back reconvened sessions of the Commissions should be continued to enable each Commission to consider, in separate meetings, agenda items included in the normative segment of its agenda.


In accordance with that decision, two meetings of the Commission on Crime Prevention and Criminal Justice will be held jointly with the Commission on Narcotic Drugs on the first day of the reconvened sessions in order to consider agenda item 3, entitled "Strategic management, budgetary and administrative questions". The remaining items on the agenda will be considered thereafter in a separate meeting. This is reflected in the proposed organization of work contained in the annex.

- (a) Work of the working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime

(b) Directives on policy and budgetary issues for the United Nations crime prevention and criminal justice programme

The Economic and Social Council, in its decision 2011/258, entitled "Improving the governance and financial situation of the United Nations Office on Drugs and Crime: extension of the mandate of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime", reaffirmed Commission on Crime Prevention and Criminal Justice resolution 18/3, entitled "Improving the governance and financial situation of the United Nations Office on Drugs and Crime", and decided to renew the mandate of the standing open-ended intergovernmental working group on improving the governance and financial situation of the Office until the part of the session of the Commission to be held in the first half of 2013, at which time the Commission should carry out a thorough review of the functioning of the working group and consider the extension of its mandate.

The terms of reference of the working group are contained in Commission on Crime Prevention and Criminal Justice resolution 18/3.

The Commission will have before it for its consideration a note by the Secretariat on the work of the working group, covering the period from February to October 2012 (E/CN.7/2012/12/Add.1-E/CN.15/2012/12/Add.1).

Item 3 will be considered at joint meetings with the Commission on Narcotic Drugs pursuant to Council decision 2011/259.

9. Provisional agenda for the twenty-second session of the Commission

Under agenda item 9, the Commission may wish to consider and take a decision on sub-items to be addressed during its thematic discussion at its twenty-second session. The Economic and Social Council, in its decision 2010/243, decided that the prominent theme for the twenty-second session of the Commission would be "The challenge posed by emerging forms of crime that have a significant impact on the environment and ways to deal with it effectively", bearing in mind paragraph 14 of the Salvador Declaration on Comprehensive Strategies for Global Challenges: Crime Prevention and Criminal Justice Systems and Their Development in a Changing World, adopted by the Twelfth United Nations Congress on Crime Prevention and Criminal Justice in 2010.

10. Other business

Under agenda item 10, the Commission may, among other things, wish to discuss inputs made by Member States on the key issues that should be considered in the post-2015 development agenda relating to the mandates of the Commission on Crime Prevention and Criminal Justice. These inputs are provided in response to the invitation from the President of the Economic and Social Council to the functional commissions to contribute to the work of the Council on this matter.

11. Adoption of the report of the Commission on its twenty-first session

Under item 11, the Commission is expected to adopt the report on its reconvened twenty-first session.

Opening of the twenty-second session of the Commission on Crime Prevention and Criminal Justice and election of officers

Pursuant to rule 16 of the rules of procedure of the functional commissions of the Economic and Social Council, the officers of the Commission on Crime Prevention and Criminal Justice hold office until their successors are elected and they are eligible for re-election.

In its resolution 2003/31, the Economic and Social Council decided that, with effect from 2004, the Commission should, at the end of each session, elect its bureau for the subsequent session and encourage it to play an active role in the preparations for both the regular and the informal intersessional meetings of the Commission, so as to enable the Commission to provide continuous and effective policy guidance to the United Nations crime prevention and criminal justice programme.

Pursuant to Economic and Social Council resolution 2003/31 and rule 15 of the rules of procedure of the functional commissions, the Commission is invited to open, at the end of its reconvened twenty-first session, on 7 December 2012, its twenty-second session for the sole purpose of electing the Chair, three Vice-Chairs and the Rapporteur for that session.

In view of the established practice of rotating the offices on the basis of regional distribution, the officers to be elected by the Commission for its twenty-first session will be from the regional groups as follows:

Chair: African States

First Vice-Chair: Eastern European States

Second Vice-Chair: Latin American and Caribbean States
Third Vice-Chair: Western European and other States

Rapporteur: Asia-Pacific States

Also in accordance with Economic and Social Council resolution 2003/31, the Chairs of the five regional groups, the Chair of the Group of 77 and China and the representative of or observer for the State holding the Presidency of the European Union will be invited to participate in meetings of the bureau, thus constituting, together with the elected officers, the extended bureau.
