D'ordre de mon gouvernement et comme suite aux lettres que je vous ai adressées les 16 à 20 et 23 à 25 avril, 7, 11, 14 à 16, 18, 21, 24, 29 et 31 mai 2012 et 1^{er}, 4, 6, 7, 11 et 19 juin 2012, j'ai l'honneur de vous faire tenir ci-joint une liste détaillée des violations des dispositions du plan prévoyant la cessation de la violence, commises le 14 juin 2012 par des groupes armés en Syrie (voir annexe).

Je vous serais reconnaissant de bien vouloir faire distribuer le texte de la présente lettre et de son annexe comme document du Conseil de sécurité.

Thursday, 14 June 2012

Rif Dimashq governorate

- 1. On 13 June 2012 at 2000 hours, an armed terrorist group blocked the Damascus Homs road near the Tayyibah rest stop and hijacked a Shallah Company bus containing 10 passengers. The law enforcement forces intervened, reopened the road and freed all the abducted passengers, excluding Chief Warrant Officer 'Ali Ibrahim.
- 2. On 13 June 2012 at 2100 hours, an armed terrorist group stole a Mercedes, licence plate No. 614771, in Nabk district. The car had been assigned to Brigadier General 'Adnan Sakif.
- 3. On 13 June 2012 at 2245 hours, an armed terrorist group blocked the Damascus Homs highway in Nabk district in three places.
- 4. On 13 June 2012 at 0000 hours, an armed terrorist group hijacked two buses in the Yabrud area, one belonging to the Hasan Company and the other to the Manar Company.
- 5. At 1200 hours, an armed terrorist group fired three rocket-propelled grenades at a military barracks in Shaifuniyah, killing Private Mahmud al-Qasim.
- 6. At 0100 hours, an armed terrorist group opened fire on the Fatlah border guard post.
- 7. At 0200 hours, an armed terrorist group opened fire on a law enforcement checkpoint in 'Artuz.
- 8. At 0700 hours, an armed terrorist group targeted a law enforcement patrol by detonating an explosive device as the patrol passed on the road linking the villages of Asad and Sabburah. Seven patrol members were wounded.
- 9. At 0930 hours, an armed terrorist group opened fire on a vehicle transporting food in the village of Humayrah, killing Conscript Tamir al-'Azu and wounding three soldiers.
- 10. At 1030 hours, an armed terrorist group in the village of Zabdin abducted Corporal Amir Ashraf.
- 11. At 1100 hours, an armed terrorist group opened fire on a law enforcement Volkswagen in the area of Hurnah. The vehicle crashed and was then stolen.
- 12. At 1200 hours, an armed terrorist group set up an armed ambush targeting Colonel Nadir Sulayman as he was passing on Dannun Zakiyah road, wounding him and his driver.

- 13. Armed terrorists in a Mercedes vehicle fired at a ZIL military vehicle on Humayrah Mahin road, killing Conscript Haytham al-Khatib and wounding two soldiers, who were rushed to the Dayr 'Atiyah Hospital.
- 14. A group of 150 armed terrorists attempted to cut the highway between Nabk and Dayr 'Atiyah. Law enforcement officers confronted them, compelled them to flee and opened the road.
- 15. An armed terrorist group stole a Government Mazda pickup belonging to the Irrigation Company, licence plate No. 930537 (Rif Dimashq), from its driver, Muhsin 'Umar Hamud.
- 16. An armed terrorist group in Martyrs Square in Duma stole an Isuzu belonging to the Public Printing Establishment, licence plate No. 893294 (Damascus), from its driver, Nasib Taha.
- 17. An armed terrorist group in Duma stole a closed Hyundai vehicle, licence plate No. 531588 (Damascus) from its driver, Subhi Husain. The vehicle belongs to the Public Printing Establishment.
- 18. An armed terrorist group abducted Volunteer Sergeant Ra'ad Mahmud Hasan as he was going to his work in Tall.
- 19. A group of 50 armed terrorists in the city of Duma used three trucks to steal 400 tonnes of iron from Shaifuniyah Construction Establishment warehouses.
- 20. An armed group of more than 30 terrorists entered the 'Awad 'Amurah Company in the town of Nashabiyah and stole a Hyundai van, licence plate No. 264732 (Damascus) and a Toyota microbus, licence plate No. 220500 (Rif Dimashq). The group also smashed the contents of the Company building.
- 21. In the city of Harasta, an armed terrorist group stole a Ford vehicle, licence plate No. 017609, belonging to Police Officer Khalid Rahmun of the Rif Dimashq Traffic Department.
- 22. In the city of Tall, an armed terrorist group stole a Nissan ambulance, licence plate No. 531822 (Rif Dimashq), from its driver.
- 23. In the village of 'Irbin, the body of an unidentified 30-year-old man was found. The body was transported to Mujtahid Hospital.
- 24. In the town of Malihah, an armed terrorist group stole an Asia microbus, licence plate No. 625246 (Damascus), from its owner, Muhammad Jamal Darwish.
- 25. A white van, licence plate number unknown, was used in an attempt to storm and enter the gate of Sayyida Zainab parking lot, south of the shrine. Police opened fire on the van, which crashed into a bus that was parked at the location and exploded. Fourteen persons, most of them residents of the area, were wounded by shattered glass. The adjacent buildings were also damaged. The explosion, involving an estimated 400 kg of explosives, created a 1.5 metre deep crater in the ground.
- 26. An armed terrorist group used a rocket-propelled grenade to attack law enforcement headquarters near Sayyidah Zainab.
- 27. An armed terrorist group opened fire on a civilian, Lu'ay 'Ali Fayyad (35 years old), who was rushed to Riyad Hospital and pronounced dead on arrival.

- 28. An explosive device weighing 50 kg was used to target a military vehicle on the Sabburah Qura al-Asad Road, in the vicinity of the Pharaonic Village. Three soldiers were injured.
- 29. The body of an unidentified person killed by a gunshot was found in the town of 'Irbin.
- 30. An armed terrorist group stole a Saba passenger vehicle, licence plate No. 606280 (Damascus), from its driver, Rudy 'Uthman, in the town of Darayya.
- 31. An armed terrorist group stole a Government Toyota, licence plate No. 896523 (Damascus), from its driver, Muhammad Ziyad Tabilah, in the town of Darayya.
- 32. In the town of Darayya, an armed terrorist group stole a Government-owned closed Mazda vehicle, licence plate No. 930792 (Rif Dimashq), belonging to the Water Establishment in Damascus and Rif Dimashq.
- 33. An armed terrorist group opened fire on a military Volkswagen vehicle, licence plate No. 192539, being driven by a soldier, Mas'ud Salih Mas'ud (born in 1958), killing him immediately.
- 34. An armed terrorist group attacked the General Agricultural Research Authority centre in the city of Duma and stole three vehicles: a Micro Mazda, licence plate No. 931044; a Prado saloon car, licence plate No. 878367; and a double-cabin Mitsubishi, licence plate No. 539749.
- 35. An armed terrorist group opened fire on Colonel Nadir Sulayman Muhammad, wounding him in his foot.
- 36. An armed terrorist group in the town of Malihah stole a Government Mitsubishi Lancer vehicle, licence plate No. 665346 (Damascus), belonging to the Real Estate Bank.
- 37. An armed terrorist group stole a Government-owned Tiger motorcycle, licence plate No. 3757 (Rif Dimashq), and 166,900 Syrian pounds from the Rif Dimashq Agricultural Directorate.

Damascus governorate

38. At 1300 hours, an armed terrorist group planted an explosive device at the Agricultural College on 'Adwi Highway. Engineering personnel defused the device.

Dar'a governorate

- 39. On 13 June 2012 at 2030 hours, an armed terrorist group opened fire on law enforcement officers at the dam intersection point.
- 40. On 13 June 2012 at 2100 hours, an armed terrorist group stole a Government Mazda pickup, licence plate No. 41672, in Basra Square, Dar'a and abducted Sergeant Qutaybah al-Kilani, who was able to escape and return to his duty station.
- 41. On 13 June 2012 at 2130 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Yadudah, killing Captain Diya' Fayyad.
- 42. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on border guard personnel in the area of Tall Zar' al-Wadi.

- 43. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on a law enforcement roadblock in the vicinity of Nazlat al-Kahraba'.
- 44. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers near Masakin al-Shabab and Uqbah Ibn Nafi' mosque.
- 45. On 13 June 2012 at 2230 hours, an armed terrorist group opened fire on border guard personnel in the area of Dahdah.
- 46. At 0330 hours, an armed terrorist group opened fire on guard post No. 32.
- 47. At 0800 hours, an armed terrorist group opened fire on the Nasib border centre, killing a civilian, Marwan 'Arafat, and wounding another civilian.
- 48. At 0800 hours, an armed terrorist group stole a vehicle on the Damascus-Dar'a highway that belonged to a civilian, 'Asim Qutayfan.
- 49. At 0845 hours, an armed terrorist group in the village of Tayhah abducted a civilian, Ahmad al-'Uqlah.
- 50. At 0900 hours, an armed terrorist group stopped a civilian, Qasim al-Musalimah, the chairman of the Chamber of Commerce and Industry in Dar'a, on the Damascus Dar'a highway and stole his car and the sum of 50,000 Syrian pounds.
- 51. At 1100 hours, an armed terrorist group abducted Warrant Officer Ratib 'Awdah from the street in Basr al-Harir.
- 52. At 1300 hours, an armed terrorist group opened fire on a vehicle transporting food to law enforcement forces and on a law enforcement checkpoint on Dayr al-Bakht Road.
- 53. At 1300 hours, an armed terrorist group opened fire on two law enforcement points, Manshiyah and Sajnah.
- 54. At 1400 hours, an armed terrorist group abducted Police Officer Nidal al-Jabarin from near Ghariyah Sharqiyah bridge on the Dar'a Damascus highway, as he was returning from work.
- 55. At 1400 hours, an armed terrorist group on the Shaykh Miskin Namir road abducted Sergeant Kamal Badr Abdullah.
- 56. At 1500 hours, an armed terrorist group opened fire on the Hamidat al-Tahir law enforcement point, killing Conscript Yusuf Salih.
- 57. An unidentified mutilated body bearing signs of torture on the hands and face was found between the towns of 'Abidin and Ma'ariyah. The body was taken to the cold storage facility at the National Hospital in Dar'a.

Homs governorate

- 58. On 13 June 2012 at 1915 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the municipal playing field, wounding one officer.
- 59. On 13 June 2012 at 1915 hours, an armed terrorist group opened fire from the direction of Bab al-Siba' and the Murayjah quarter on law enforcement officers in the vicinity of Farabi school.

- 60. On 13 June 2012 at 1915 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers in Qusayr.
- 61. On 13 June 2012 at 1930 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades and mortars at law enforcement officers in the Qusur quarter, killing Major 'Ali Rujuh and wounding four officers, including First Lieutenant 'Ali al-As'ad.
- 62. On 13 June 2012 at 1930 hours, an armed terrorist group opened fire on law enforcement officers in the village of Hisn, Tall Kalakh.
- 63. On 13 June 2012 at 2000 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the dam and the villages of Bassas and 'Artumah, wounding one officer.
- 64. On 13 June 2012 at 2015 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers on Cairo street, wounding one officer.
- 65. On 13 June 2012 at 2100 hours, an armed terrorist group opened fire on law enforcement officers in the Khalidiyah quarter, wounding five officers.
- 66. On 13 June 2012 at 2130 hours, an armed terrorist group abducted Major Ziyad Darwish in the village of Zarah and stole his car, licence plate No. 44855.
- 67. On 13 June 2012 at 2130 hours, an armed terrorist group opened fire on law enforcement officers in the Qarabid quarter, wounding one officer.
- 68. On 13 June 2012 at 2145 hours, an armed terrorist group stole a car, licence plate No. 296709, which had been issued to Colonel Musa Mansur. The car was stolen from in front of his home on the Homs Hamah road, Gharnatah turnoff, in the vicinity of Musafir mosque.
- 69. On 13 June 2012 at 2145 hours, an armed terrorist group opened fire intermittently on law enforcement officers in the vicinity of the National Hospital in Tall Daw.
- 70. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers in front of the police command in Homs, wounding one officer.
- 71. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers in Talbisah.
- 72. On 13 June 2012 at 2300 hours, an armed terrorist group opened fire on law enforcement officers in Wadi al-Sayih and in the vicinity of Hubus restaurant.
- 73. On 13 June 2012 at 2300 hours, an armed terrorist group opened fire on guard posts Nos. 235 and 236 at the Homs Refinery, wounding one officer.
- 74. On 13 June 2012 at 2315 hours, an armed terrorist group opened fire on and fired mortar bombs from the direction of Bab al-Turkuman at law enforcement officers in the vicinity of the citadel.
- 75. On 13 June 2012 at 0015 hours, an armed terrorist group opened fire from buildings opposite the blood bank in the Wa'r quarter on law enforcement officers in the vicinity of the military hospital.

- 76. On 13 June 2012 at 0030 hours, an armed terrorist group opened fire on law enforcement officers in Bab Tadmur, wounding one officer.
- 77. On 13 June 2012 at 0050 hours, an armed terrorist group opened fire on law enforcement officers in the Hamidiyah quarter.
- 78. At 0100 hours, an armed terrorist group opened fire on law enforcement officers in the Jurat al-Shiyah quarter, wounding First Lieutenant Ibrahim Mahmud and another officer.
- 79. At 0200 hours, an armed terrorist group opened fire on law enforcement officers in the Khalidiyah quarter, wounding one officer.
- 80. At 0400 hours, an armed terrorist group opened fire on law enforcement officers in the Warshah quarter, wounding one officer.
- 81. At 0500 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the village of Tall al-Nasr.
- 82. At 0515 hours, an armed terrorist group fired five mortar bombs at law enforcement officers in the vicinity of Gardenia Tower in the Ghutah quarter.
- 83. At 0630 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of Shalhub roundabout and the monument in Rastan, wounding seven officers, including Captain Firas Najmaldin Sulayman.
- 84. At 0700 hours, an armed terrorist group opened fire on law enforcement officers in the Karm Shamsham quarter, wounding eight officers.
- 85. At 0700 hours, an armed terrorist group opened fire on law enforcement officers in Talbisah, wounding an officer.
- 86. At 0730 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the nursery and the 'Aqrabiyah village turnoff in Qusur.
- 87. At 0800 hours, an armed terrorist group attacked five 4th Company guard posts.
- 88. At 0800 hours, an armed terrorist group abducted, tortured and killed Chief Warrant Officer Jum'ah al-Shamali and abducted Police Officer Khalid Maju when they were going to their home in the village of Tallaf Hulah.
- 89. At 0900 hours, an armed terrorist group opened fire on law enforcement officers in the village of Sultaniyah, wounding two officers, including Major Naji Shahadah.
- 90. At 0900 hours, an armed terrorist group opened fire on Captain 'Ammar Dayyub as he was heading to his home on the outskirts of Majd. He was wounded by a gunshot to the head and is in critical condition.
- 91. At 0930 hours, an armed terrorist group opened fire from the direction of the farms on law enforcement officers in the vicinity of the village of Hasawiyah.
- 92. At 1000 hours, an armed terrorist group opened fire on and fired a mortar bomb at law enforcement officers in the vicinity of Suq al-Hal roundabout.
- 93. At 1115 hours, an armed terrorist group fired rockets from the direction of Bab al-Turkuman, the Warshah quarter and Bab al-Siba' at law enforcement officers in the vicinity of Farabi school.

- 94. At 1400 hours, an armed terrorist group intercepted a car, licence plate No. 785098, belonging to Brigadier General Akram Tawfiq Tajur. The car was stolen and the driver, Conscript 'Abd Muhammad Ma'adamani, was abducted.
- 95. At 1400 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of Dik al-Dajn restaurant in the Wa'r quarter.
- 96. At 1430 hours, an armed terrorist group opened fire from the direction of the orchards in the Wa'r quarter on law enforcement officers in the vicinity of Qawasi' mosque.
- 97. At 1420 hours, an armed terrorist group fired a mortar bomb at law enforcement officers in the vicinity of the university campus.
- 98. At 1430 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the Dye Houses Company, wounding one officer.
- 99. At 1430 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the entrance to Talbisah.
- 100. At 1500 hours, an armed terrorist group on the road between Rastan and Talbisah stole a Government car, licence plate No. 543708. The car belongs to the Dayr al-Zawr Education Directorate.
- 101. At 1515 hours, an armed terrorist group opened fire on law enforcement officers in the vicinity of the cultural centre, wounding one officer.

Hama governorate

- 102. On 13 June 2012 at 2040 hours, an armed terrorist group fired a rocket-propelled grenade at a law enforcement checkpoint in the vicinity of Bahrah roundabout. It then fired heavily on the checkpoint.
- 103. On 13 June 2012 at 2040 hours, an armed terrorist group fired two rocket-propelled grenades at the law enforcement checkpoint in the vicinity of the Federation of Workers building.
- 104. On 13 June 2012 at 2130 hours, an armed terrorist group opened fire on a law enforcement checkpoint in the vicinity of A'laf roundabout.
- 105. On 13 June 2012 at 2100 hours, an armed terrorist group abducted a civilian, Safa As'ad, as he was working at the grain sieve he owns west of the village of Karamah Ghab.
- 106. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on and wounded Conscript Buzu Hasan in the village of Tuwaynah.
- 107. On 13 June 2012 at 0000 hours, an armed terrorist group opened fire on and fired a rocket-propelled grenade at the law enforcement building in Hammamat.
- 108. On 13 June 2012 at 0040 hours, an armed terrorist group opened fire on a law enforcement checkpoint in the Sabuniyah quarter.
- 109. At 0730 hours, an armed terrorist group intercepted engineer Nabil al-Shamali as he was driving in a Government car, licence plate No. 632794. It abducted him and stole the car.

- 110. At 0730 hours, an armed terrorist group stole a truck loaded with flour and abducted its driver near the village of Juruh on the Raqqah Salmiyah road.
- 111. At 0730 hours, an armed terrorist group set up an ambush and opened fire on a car, licence plate No. 493372, on the Suqaylibiyah Muhradah Hayyalin road. It killed and stole the weapons of Chief Warrant Officer Muhammad al-Akhras, Police Officer Rabi' Makhluf and Police Officer Husam Badr.
- 112. At 0930 hours, an armed terrorist group shot and wounded a civilian, Abduljabbar Farzat.
- 113. At 0955 hours, an armed terrorist group shot and wounded a civilian, Muhammad al-'Ajuz, in the village of Qasr Abu Samrah, Hamrah subdistrict.
- 114. At 1000 hours, an armed terrorist group abducted a soldier, Abdulrahman Husayin, in the village of Zalaqiyat.
- 115. At 1100 hours, an armed terrorist group abducted Colonel Badr Abdulhamid as he was going to his work.
- 116. At 1230 hours, an armed terrorist group in the Hadir quarter stole a Government car, licence plate No. 939138, belonging to the General Company for Roads and Bridges.
- 117. At 1300 hours, an armed terrorist group in the vicinity of Dawr Office stole a car, licence plate No. 335080, from its civilian owner, Muwaffaq Lutfi.
- 118. At 1400 hours, an armed terrorist group stole a Government vehicle, licence plate No. 632968, on Abi al-Fida' Street. The vehicle belongs to the Transportation Directorate.
- 119. At 1615 hours, an armed terrorist group fired two grenades from the direction of the Murabit quarter at a law enforcement checkpoint in the vicinity of the old party branch headquarters in 'Asi Square.

Aleppo governorate

- 120. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers in Hurriyatan, killing Conscript 'Abdullah al-Jubayli and Sergeant Sulayman Sayf and wounding six officers.
- 121. On 13 June 2012 at 2300 hours, an armed terrorist group planted eight explosive devices on the Khan al-'Asal Atarib road.
- 122. At 1000 hours, an armed terrorist group fired in the air in the vicinity of the postal centre in the Hajj Bridge area and forced store owners to close their stores.
- 123. At 1030 hours, an armed terrorist group opened fire on law enforcement officers in Atarib, wounding Captain Muhammad Khayrbek.
- 124. At 1100 hours, an armed terrorist group fired a rocket-propelled grenade at a law enforcement checkpoint in the vicinity of Ballirmun, wounding two officers.

Idlib governorate

125. On 13 June 2012 at 2200 hours, an armed terrorist group opened fire on law enforcement officers in the city of Idlib, wounding one officer.

- 126. At 0500 hours, an armed terrorist group detonated a booby-trapped car in the vicinity of a law enforcement checkpoint on the Idlib Harim road, at the western entrance to Idlib, wounding one officer and five soldiers.
- 127. At 1530 hours, an armed terrorist group targeted a law enforcement forces food supply vehicle on the Ariha Jisr al-Shugur Basanqul road, killing Conscript Ahmad 'Abu and wounding four officers.

Dayr al-Zawr governorate

- 128. On 13 June 2012 at 2100 hours, an armed terrorist group set up two roadblocks, one in the vicinity of Bulayl on the Dayr al-Zawr road in the Muhassan subdistrict, and one opposite the village of Burqrus, on the new road.
- 129. On 13 June 2012 at 2200, an armed terrorist group opened fire on law enforcement officers in Dayr al-Zawr, wounding 14 officers.
- 130. On 13 June 2012 at 2230 hours, an armed terrorist group abducted officers from the Criminal Security Branch and threatened to kill residents if they opened their stores.
- 131. On 13 June 2012 at 2330 hours, an armed terrorist group set up a roadblock in the vicinity of the Martyrs Cemetery in Dayr al-Zawr. It intercepted two passing vehicles and forced police and law enforcement officers to get out of the vehicles.
- 132. At 0100 hours, an armed terrorist group opened fire on soldiers manning guard post No. 226 in the area of Rawdah.
- 133. At 0400 hours, an armed terrorist group opened fire on a law enforcement checkpoint in the village of Suwayi`ah, Abu Kamal.
- 134. At 0430 hours, an armed terrorist group opened fire on a military barracks in Dayr al-Zawr, wounding one soldier.
- 135. At 0730 hours, an armed terrorist group opened fire on a border guard patrol in the vicinity of Misriyah roundabout in Abu Kamal, wounding one patrol member.
- 136. At 0800 hours, an armed terrorist group opened fire on law enforcement officers in Dayr al-Zawr, killing Conscript Wa'il Hajj Yasin, Corporal Muhammad Sakar and Police Officer Ma'an Dayyub.
- 137. At 0815 hours, in the vicinity of the fire department on Bur Sa'id road, an armed terrorist group intercepted a law enforcement forces bus, licence plate No. 392786. It beat and insulted the driver and stole the bus.
- 138. At 0900 hours, an armed terrorist group opened fire on the police command building in Dayr al-Zawr, killing one officer.
- 139. At 1000 hours, an armed terrorist group opened heavy fire on the border guard battalion headquarters in Abu Kamal, wounding two soldiers.
- 140. At 1200 hours, an armed terrorist group planted two explosive devices on the public road in Abu Kamal. First Lieutenant Mahmud Sulayman was injured as he attempted to defuse the devices.
- 141. At 1400 hours, an armed terrorist group opened fire on and fired rocket-propelled grenades at law enforcement officers as they opened the Dayr al-Zawr Mayadin road near the bus station, killing Conscript Hasan al-'Ujayl and Sergeant

Hazzam al-Ruways, wounding nine others, destroying three vehicles and hitting another vehicle. The group also abducted an officer.

- 142. At 1400 hours, an armed terrorist group set up a roadblock at the fire department in the vicinity of the bus station. It inspected passers-by and prevented students from travelling. It also killed a civilian and dumped his body near 'Arfi girls secondary school.
- 143. At 1530 hours, an armed terrorist group stormed Duwayr Mayadin postal sorting office. The building was wrecked and a rifle stolen.
- 144. At 1600 hours, an armed terrorist group opened fire on law enforcement officers in Dayr al-Zawr, killing Conscript Abdulkarim al-Salim.
- 145. At 1610 hours, an armed terrorist group fired a number of mortar bombs at a military barracks in Dayr al-Zawr.
- 146. At 1930 hours, an armed terrorist group opened fire on border guard personnel at Hardan guard post, wounding three soldiers.
- 147. First Lieutenant Muhammad Taqash, the head of the Criminal Security Centre in Mayadin, died after being shot in the head as he was travelling to his office in a civilian vehicle.

Ladhiqiyah governorate

- 148. At 1800 hours, an armed terrorist group opened fire using all types of weapon on law enforcement officers in Haffah, killing Conscript 'Imad Hamad, labourer Nizar Salamah, Warrant Officer Muhammad 'Ali, Master Sergeant 'Ala' 'Ali, Sergeant Ghadir Muhammad, Chief Warrant Officer Muhammad As'ad and Conscript Ibrahim Taqtuq and wounding 21 officers.
- 149. Sticks of dynamite blew up next to Shukri Hakim school in the Salibah quarter, without causing any injuries or damage.

Hasakah governorate

150. At 1000 hours, an armed terrorist group blocked the Dayr al-Zawr — Hasakah road in the vicinity of Markadah subdistrict.

Syrian — Lebanese border

- 151. On 13 June 2012 at 2300 hours, an armed terrorist group opened fire from Lebanese territory on three border guard posts in Tall Kalakh.
- 152. At 1230 hours, an armed terrorist group opened fire from Lebanese territory on the soldiers manning the Tamim 'Aziz guard post.
- 153. At 0100 hours, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory and opened fire on border guard personnel in Jusiyah.
- 154. At 1630 hours, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory and opened fire on border guard personnel.

Syrian — Iraqi border

155. On 13 June 2012 at 2130 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory in the area of Shaddadah and opened fire on border guards.

156. On 13 June 2012 at 0050 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on border guards in the area of Jaz'ah.

157. At 0330 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on border guards in the area of Jaz'ah.
