Sustainable development: follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States

Draft resolution submitted by the Rapporteur of the Committee, Aida Hodžić (Bosnia and Herzegovina), on the basis of informal consultations on draft resolution A/C.2/67/L.7

International Year of Small Island Developing States

The General Assembly,

Reaffirming the Declaration of Barbados¹ and the Programme of Action for the Sustainable Development of Small Island Developing States,² the Mauritius Declaration³ and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,⁴ chapter 17 of Agenda 21,⁵ and the Plan of Implementation of the World Summit on Sustainable Development (“Johannesburg Plan of Implementation”),⁶ including chapter VII on the sustainable development of small island developing States,

Recalling the outcome document of the High-level Review Meeting on the Implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,⁷ General Assembly resolutions 65/156 of 20 December 2010 and 66/198 of 22 December 2011 and all its other previous resolutions on the subject,

Recalling also the outcome document entitled “The future we want” of the United Nations Conference on Sustainable Development,⁸ adopted by the General Assembly on 27 July 2012, recognizing the importance of coordinated, balanced and integrated actions to address the sustainable development challenges facing small island developing States,

Reaffirming Economic and Social Council resolution 1980/67 of 25 July 1980 on international years and anniversaries and General Assembly resolutions 53/199 of 15 December 1998 and 61/185 of 20 December 2006 on the proclamation of international years,

1. *Decides* to declare 2014 the International Year of Small Island Developing States;

2. *Invites* the Secretary-General, in consultation with relevant agencies within the United Nations system and mindful of the provisions of the annex to Economic and Social Council resolution 1980/67, to facilitate the implementation of the Year, and stresses that the costs of all activities that may arise from the implementation of the present resolution above and beyond activities currently within their mandates should be met through voluntary contributions;

3. *Encourages* all Member States, the United Nations system and all other stakeholders to take advantage of the Year to promote actions at all levels, including through international, regional and subregional cooperation, as appropriate, aimed at the achievement of sustainable development of small island developing States;

4. *Requests* the Secretary-General, in his annual report on the follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, to report to the General Assembly at its seventieth session on the implementation of the present resolution, inter alia, elaborating on the evaluation of the Year, including its financial aspects.
