par le Représentant permanent de la République arabe  
syrienne auprès de l'Organisation des Nations Unies**

D'ordre de mon gouvernement et comme suite aux lettres que je vous ai adressées les 16 à 20 et 23 à 25 avril, 7, 11, 14, 16 à 18, 21, 24, 29 et 31 mai, 1<sup>er</sup>, 4, 6, 7, 11, 19, 20, 25, 27 et 28 juin, 2, 3, 9, 11, 13, 16, 17 et 24 juillet et 1<sup>er</sup>, 2 et 8 août 2012, j'ai l'honneur de vous faire tenir ci-joint une liste détaillée des violations des dispositions du plan prévoyant la cessation de la violence, commises par des groupes armés en Syrie entre la soirée du vendredi 27 juillet et celle du samedi 28 juillet 2012 (voir annexe).

Je vous serais reconnaissant de bien vouloir faire distribuer le texte de la présente lettre et de son annexe comme document du Conseil de sécurité.
