Commission on the Status of Women Fifty-seventh session 4-15 March 2013 Follow-up to Economic and Social Council resolutions and decisions

## Letter dated 29 November 2012 from the President of the Economic and Social Council to the Chair of the Commission on the Status of Women

The 2012 high-level segment of the Economic and Social Council, held in July 2012, considered ways to deal with the global jobs crisis, by focusing on the areas of unemployment, productive capacity, social protection floors, and development cooperation. By promoting consensus and facilitating discussions, the Council ensured a renewed focus on the link between the current jobs crisis and the ongoing need to strive for inclusive and sustainable development. The ministerial declaration of the high-level segment (see A/67/3, chap. III, para. 139) thus stressed the need for immediate collective action by the international community to address the global jobs crisis.

The Economic and Social Council also convened its biennial Development Cooperation Forum where participants proposed practical recommendations for meeting specific emerging challenges, as well as ways to further enhance development coherence.

The operational activities segment of the 2012 substantive session of the Economic and Social Council focused on the 2012 quadrennial comprehensive policy review of the General Assembly, and nearly all programme countries requested that programming instruments be better streamlined and harmonized at the country level, while, at the same time, still maintaining sufficient levels of flexibility. It also called on the United Nations development system as a whole to greatly simplify and harmonize its business practices.

At the humanitarian affairs segment of the 2012 substantive session of the Economic and Social Council, the Council succeeded in shining the spotlight on the world's most dire emergencies as well as in touching upon ways to improve its capacity to confront future crises swiftly. Moreover, it placed greater emphasis on integrating empiricism more tightly into humanitarian decision-making and partnerships, and discussed the Secretary-General's first report on the implementation

of integrated, coherent and coordinated support to South Sudan by the United Nations system (E/2012/76).

Finally, attention was given to the follow-up to the United Nations Conference on Sustainable Development and the strengthening of the Council, including its working methods, so as to enable it to effectively fulfil its functions of giving special attention to the integrated and coordinated implementation of all major United Nations conferences and summits in the economic, social, environmental and related fields.

In addition to the ministerial declaration, a total of 33 resolutions and 44 decisions were adopted by the Economic and Social Council at its substantive session. A list of those resolutions that have relevance to the functional commissions has been prepared (see annex).

I would greatly appreciate it if this list could be brought to the attention of the Commission on the Status of Women for consideration and action (if necessary), and wish to thank you for your continued assistance and collaboration in this regard.
