Programme budget implications of draft resolution I recommended by
the Second Committee in its report (A/39/790/Add.10, para. 17)

Report of the Fifth Committee

1. At its 36th meeting, on 28 November 1984, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/39/41) on the programme budget implications of draft resolution I recommended by the Second Committee in paragraph 17 of its report (A/39/790/Add.10). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/39/SR.36).

DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 92 to 2, with 11 abstentions, to inform the General Assembly that, should it adopt draft resolution I recommended by the Second Committee in paragraph 17 of its report (A/39/790/Add.10), an additional appropriation of \$36,200 would be required under section 19 of the programme budget for the biennium 1984-1985.
4. Conference-servicing requirements would arise which are estimated, on a full-cost basis, at \$46,000. The actual additional appropriation that might be required in that respect would be considered in the context of the consolidated

statement of conference-servicing requirements to be submitted at a later stage during the current session.

5. The voting was as follows:

Against: Israel, United States of America.

Abstaining: Australia, Belgium, Canada, France, Germany, Federal Republic of, Grenada, Ireland, Italy, Japan, Netherlands, United Kingdom of Great Britain and Northern Ireland.

6. Statements in explanation of vote were made by the representatives of Egypt, Denmark, Greece, Ireland, the United Kingdom of Great Britain and Northern Ireland, France, Belgium, Italy, the Netherlands and the Federal Republic of Germany.
