#### ORGANIZATION OF WORK

### Note by the Secretariat

1. In order to assist the Sixth Committee in the organization of its work, the Secretariat finds it appropriate, in the light of General Assembly resolutions 1898 (XVIII) of 11 November 1963 and 32/71 of 9 December 1977 and of rule 99 (b) of the rules of procedure of the General Assembly, to draw the Sixth Committee's attention to the following.

### I. ITEMS ALLOCATED TO THE SIXTH COMMITTEE

2. At its 3rd plenary meeting, on 22 September 1989, the General Assembly decided to allocate to the Sixth Committee 11 items. The titles of these items and their numbers are reproduced in the letter dated 22 September 1989 from the President of the General Assembly addressed to the Chairman of the Sixth Committee (A/C.6/44/1).

### II. DOCUMENTATION RELATING TO THE ITEMS ALLOCATED TO THE SIXTH COMMITTEE

3. The following table lists the documents of the forty-fourth session of the General Assembly relating to the items allocated to the Sixth Committee.\* It includes references to the reports of commissions or committees and the reports which are to be submitted by the Secretary-General pursuant to resolutions or decisions of preceding sessions of the General Assembly, as well as to the documents circulated under the agenda items allocated to the Sixth Committee, in accordance with requests of Member States. The items are arranged in the order in which they appear in the letter dated 22 September 1989 from the President of the General Assembly to the Chairman of the Sixth Committee (A/C.6/44/1).

> III. DATE FOR CONCLUDING THE WORK OF THE COMMITTEE, ORDER AND APPROXIMATE DATES OF CONSIDERATIONS OF ITEMS

Rule 99 (b) of the rules of procedure of the General Assembly provides that: 4.

"Each Main Committee, taking into account the closing date for the session fixed by the General Assembly on the recommendation of the General Committee, shall adopt its own priorities and meet as may be necessary to complete the consideration of the items referred to it. It shall at the beginning of the session adopt a programme of work indicating, if possible, a target date for the conclusion of its work, the approximate dates of consideration of items and the number of meetings to be allocated to each item".

5. It is to be mentioned that the General Committee, at its 1st meeting, on 20 September 1989, decided to recommend that no closing date for the forty-fourth session should be set and that every effort should be made to curtail the duration of the session. Under the circumstances, it appears advisable that the Sixth Committee should arrange its schedule of meetings in such a way that it will conclude its work not later than Thursday, 30 November 1989.

Taking into account the pattern followed by the Committee in the order of 6. consideration of items at recent sessions of the General Assembly and without

prejudice, of course, to appropriate adjustments which might be required if the Assembly decides on the curtailment of the duration of the forty-fourth session, the Sixth Committee may wish to consider, for the purpose of adopting its programme of work, the following timetable, drawn on the basis of previous programmes of work adopted by the Committee, which indicates approximate dates of consideration of agenda items referred to it.

## IV. ESTABLISHMENT OF SUB-COMMITTEES OR WORKING GROUPS AND HOLDING OF CONSULT TIONS

7. It appears that, as in the past, the Sixth Committee will have to consider the establishment of sub-committees or working groups of limited size but representative of its membership, for the purpose of facilitating the work. In this connection, it should be borne in mind that the General Assembly and its subsidiary bodies took the following decisions or recommendations which are relevant for these purposes:

(a) With respect to agenda item 146, the <u>Ad Hoc</u> Committee on the Drafting of an International Convention against the Recruitment, Use, Financing and Training of Mercenaries recommended, at its 1989 session, in paragraph 11 of its report, 1/"that the Sixth Committee should entrust a working group at the forty-fourth session with the task of settling outstanding issues, thus producing a draft convention do submit to the General Assembly at that session. The Working Group should meet for a maximum period of two weeks at the beginning of the session". As a result of informal open-ended consultations held on 11 September 1989, under the chairmanship of the Legal Counsel, on organizational aspects of such a working group, there was a general agreement that:

- (i) As recommended by the <u>Ad Hoc</u> Committee, an open-ended working group be established by the Sixth Committee at the forty-fourth session of the General Assembly;
- (ii) The manuate of the working group be defined, taking into account paragraph 11 of the report of the <u>Ad Hoc</u> Committee set out above;
- (iii) The working group should meet simultaneously but not in parallel with the Sixth Committer for two weeks from 26 September to 10 October 1989, as was recommended by the <u>Ad Hoc</u> Committee. Towards the end of the second week the Chairmen of the Sixth Committee and of the Working Group should consult in order to determine whether or not the working group will be able to complete its mandate.

(b) Regarding eqenda item 147, it is to be recalled that the General Assembly recommended the continuation of efforts to improve the ways in which the report of the International Law Commission is considered in the Sixth Committee, with a view to providing effective guidance for the Commission in its work. The General Assembly also decided that the Sixth Committee, in structuring its debate on the report of the International Law Commission, should bear in mind the possibilities of reserving time for informal exchanges of views on matters relating to the International Law Commission (resolution 43/169 of 9 December 1988).

8. Should the Sixth Committee decide to establish sub-committees or working groups or to hold consultations on an item on its agenda, it should be bole in mind that such sub-committees, working groups or consultations would be using the conference services provided for the Committee. Therefore, it is important that in principle the planning of meetings of these sub-committees, working groups or consultations should be held instead of plenary meetings of the Committee, rather than in addition to them.

### V. DEADLINE FOR SUBMISSION OF DRAFT RESOLUTIONS WITH FINANCIAL IMPLICATIONS

9. According to rule 153 of the rules of procedure of the General Assembly, 'No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General". It is therefore imperative that the Main Committees allow sufficient time for the preparation of the estimates of expenditures by the Secretariat and for their consideration by the Advisory Committee on Administrative and Budgetary Questions and by the Fifth Committee. Under the circumstances, if Thursday, 30 November 1989, is accepted as the concluding date for the work of the Sixth Committee (see para. 5 above), Wednesday, 22 November 1989, would have to be considered as the manda ory deadline for submission to the Fifth Committee of draft resolutions with financial implications.

### VI. CONFERENCE RESOURCES AVAILABLE

10. The available conference facilities will, in principle, enable the Committee to hold an average of seven plenary meetings per week; normally, morning meetings will be held from 10 a.m. to 1 p.m. and afternoon meetings from 3 p.m. to 6 p.m.

11. In order to avoid difficulties in the organization of services for the meetings of regional groups of the Committee, it is suggested that all requests for such meetings be channelled to the Planning and Meetings Services Section through the Secretary of the Committee.
