STATUS OF THE PROTOCOLS ADDITIONAL TO THE GENEVA CONVENTIONS OF 1949 AND RELATING TO THE PROTECTION OF VICTIMS OF ARMED CONFLICTS

Report of the Secretary-General

- 1. After information was circulated on the status of the Protocols Additional to the Geneva Conventions of 1949 and relating to the protection of victims of armed conflicts, as contained in the annex to the report of the Secretary-General (A/43/532), 13 more countries have ratified or acceded to the Protocols, namely, Algeria, Côte d'Ivoire, Gambia, Greece, Hungary, Liechtenstein, Luxembourg, Mali, Malta, Nigeria, Peru, Solomon Islands and Spain.
- 2. The list of all States that have ratified or acceded to the Protocols as at 20 September 1989 as communicated by the competent authorities of the Government of Switzerland, depositary of the Protocols, appears in the annex to the present report.
