Representative of Cyprus to the United Nations addressed
to the Secretary-General**

Upon instructions from my Government, I transmit herewith the recorded infringements of international air traffic regulations and violations of the national airspace of the Republic of Cyprus by Turkey, committed during the month of December 2012. I have the honour to draw your attention to the systematic infringement by Turkey of the sovereignty and territorial integrity of the Republic of Cyprus by blatantly violating international rules in a way that seriously jeopardizes international aviation safety in the region.

I should be grateful if you would circulate this letter and its annex as a document of the General Assembly, under agenda item 43, and of the Security Council.
