# Report of the Fifth Committee

# A. Draft resolution I

- 1. At its 49th meeting, on 13 December 1984, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/39/92) on the programme budget implications of draft resolution I recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/39/SR.49).

#### DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, without objection, to inform the General Assembly that, should it adopt draft resolution I recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4), an additional appropriation of \$926,000 would be required under section 17 of the programme budget for the biennium 1984-1985.

4. A statement in explanation of position was made by the representative of the Union of Soviet Socialist Republics.

# B. Draft resolution II

- 5. At its 52nd and 53rd meetings, on 15 December, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/39/91) on the programme budget implications of draft resolution II recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 6. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary records (A/C.5/39/SR.52 and 53).

#### DECISION OF THE FIFTH COMMITTEE

- 7. The Fifth Committee decided, by a recorded vote of 71 to 17, with 11 abstentions, to inform the General Assembly that, should it adopt draft resolution II recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4), an additional appropriation of \$1,135,000 would be required under section 17 of the programme budget for the biennnium 1984-1985. An additional appropriation of \$238,500 would also be required under section 31 (Staff assessment), which would be offset by an increase of the same magnitude in the estimates of income under income section 1 (Income from staff assessment).

## C. Draft resolution

- 10. At its 53rd meeting, on 15 December, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/39/94) on the programme budget implications of draft resolution III recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
- 11. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/39/SR.53).

#### DECISION OF THE FIFTH COMMITTEE

- 12. The Fifth Committee decided, by a recorded vote of 71 to 18, with 10 abstentions, to inform the General Assembly that, should it adopt draft resolution III recommended by the Second Committee in paragraph 28 of its report (A/39/790/Add.4), an additional appropriation of \$5,000,000 would be required under section 17 of the programme budget for the biennium 1984-1985.
